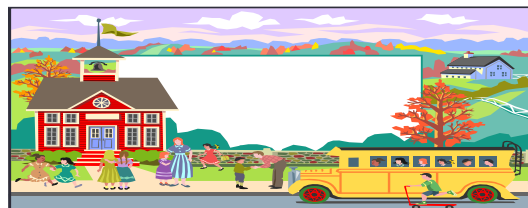

Executive Summary

This is the ninth annual report produced by the Kentucky Center for School Safety and is cause for celebration. Most importantly, these data show a dramatic reduction over the five-year period under study here in:

- Total disciplinary actions for *Part I* offenses,
- Total disciplinary actions for *Part II* offenses, and
- Disciplinary actions for the most serious offenses of aggravated assault, arson, larceny/theft and burglary.

Additionally, no criminal homicides or forcible rapes were reported for the same five-year period.

Furthermore, encouraging developments can be seen in:

- The steady decline in disciplinary actions for Board Violations that has occurred over the past five years
- A 34.3% decrease in drug abuse incidents from the 2003-2004 peak in these incidents,
- A 10.0% decrease in suspensions for board policy violations from last year's total, and an 17.4% decrease from the 2003-2004 peak in these incidents; and
- An 11.8% decrease in corporal punishments from last year's total and a 36.4% decrease over the five-year period. In 2007-2008, 52 districts throughout the state used corporal punishment at least once during the school year.

Nevertheless, not all the news from this report is good news. The number of disciplinary actions for terroristic threatening increased 74.2% over the five-year period and 11.9% between 2006-2007 and 2007-2008.

Furthermore, disciplinary actions for alcohol violations increased 27.1% between 2006-2007 and 2007-2008. Additionally, Expulsions without Services for Law violations increased 20.5% over the five-year period and 56.7% from 2006-2007 to 2007-2008 (see page 25). These findings suggest that, despite the general good news regarding school safety in Kentucky, there are still areas where further study and efforts are needed.

Due to enhanced data collection procedures, this year's report again provides information on board and Law Violations with regard to grade level, school type,

socio-economic indicators, and drug use and distribution. This additional information offers a richer database and affords advanced exploration of the complexities of student behavior. Additionally, for the first time, this report includes a comparison of disciplinary actions between those students who have an Individualized Education Plan (IEP) and those who do not.

These enhanced data collection procedures allowed us to identify distinct disciplinary action patterns by grade level, Board, and Law Violations. These data reveal that disciplinary actions for both Law and Board Violations increase dramatically between 5th and 6th grades and 8th and 9th grades. This pattern has held true for four years and supports a variety of anecdotal evidence that suggests these transition years are particularly difficult and that transition may lead to these increases in disciplinary actions.

Despite these enhancements, there are still shortcomings in the data collection process that, when addressed, will allow for much richer data analysis than is currently possible. The most important of these shortcomings involves the current inability to connect **each disciplinary action to a particular student through a unique identifier**. Currently, the discipline data are reported by infraction and disciplinary action. Although individual-level data (gender, ethnicity, grade, lunch type, special education classification, limited English proficiency, mobility, etc.) are available at the school level, we currently do not have access to that information. This makes it impossible for us to match disciplinary actions with individuals. If we had that capability, data analysis could be more thorough and detailed. For example, examination of offender recidivism is currently not possible. This connection could assist schools in evaluating programs targeted to repeat offenders. While KDE has attempted to create unique identifiers for each student in Kentucky, we are still not entirely confident that process is working effectively, and thus cannot use those unique identifiers for the students with the level of confidence needed for the in-depth analysis of those data at this point. As KDE continues to improve the process, we are hopeful that we will have access to these identifiers in the near future.

As always, KCSS is prepared to assist schools further with data usage. Training in this area is a part of the Center's training efforts. For additional information regarding training opportunities, check our website at www.kysafeschools.org.

Maintaining and improving the safety of Kentucky's students and school staff members are the driving forces behind the Kentucky Center for School Safety. However, for parents, for educators, and for community members, children must be our first priority. Consequently, the safety of Kentucky's school children is a shared responsibility. Let each of us make this responsibility a sacred trust with our future.

Introduction

School safety is everyone's concern. Teachers and students cannot be expected to perform at higher levels when they feel unsafe at school. Parents want schools to provide a secure place to send their children to learn. Educators want to facilitate learning by providing a safe and civil environment. Businesses want schools to be safe to attract good workers to the community. Government and social agencies want schools to be safe to reinforce the safety and security of the community.

School safety must be a concern for everyone in the community, because it is everyone's responsibility.

To this end, the Kentucky Center for School Safety (KCSS) provides this report of demographic data regarding disciplinary actions involving students in Kentucky's public schools. Every public school and school district in Kentucky contributed data to this report; ideally, schools, districts, and communities will use this information to maintain and improve the safety for all of Kentucky's school children.

The purpose of this report is to provide schools with state, regional, and district data for comparisons. In previous years, the “Using this Report” section has outlined basic data analysis and how to utilize the report in a comprehensive school safety plan. Refer to Appendix F for the full section in previous years.

Section I Using this Report

For the third consecutive year, with two exceptions, the data collection process for 2007-2008 remained relatively unchanged from the previous years. The first exception was the enhancement that allows us to determine the proportion of students receiving disciplinary actions discussed earlier. The second exception involved a transition from the previous data collection system (STI) to a new data collection system known as Infinite Campus (IC) for some of the school districts. Nineteen (19) districts converted from STI to IC at the beginning of the academic year. This transition caused a number of data issues, delaying the release of this report for at least four months, and preventing us from replicating all charts that were included in previous reports. The difficulties discovered during the transition, however, give us increased confidence that future reports using IC data will be even richer and more reliable because of the enhancements offered by that system. As such, while the transition between systems created some delays for this academic year, our hope is that future reports can be completed earlier in the year because of the new data collection system.

This stability represents an indication of the confidence that we now have in the reliability of the data collection process. Consequently, a database that is now more robust and reliable than previous years has provided additional information that was unavailable at the state level prior to 2004-2005. Given the confidence that we have in the reliability of the data, we again present five-year trend data in this report for most of the charts, and four-year data in those cases when we made additional modifications to the data collection process to dig deeper into the data (e.g., drug offenses, regional rates). Given the additional data points now available, we feel that trends will be more easily recognizable and thus identifiable. As such, we feel this improvement will continue to provide more helpful data for the users of these reports.

While the additions have enriched the database for this reporting period and improved the usefulness of this report, we continue to suggest that the full impact of the data collection process could be further improved with the addition of the unique identifier mentioned earlier in the report.

KCSS is committed to working with schools, districts and the Kentucky Department of Education to enhance the quality of the data report. Through a continuous process of review, assessment and modification, this report will continue to provide richer data to schools and districts in order that more effective interventions can be planned and implemented.

Data should always be reviewed in context. For example, a school with an increase in suspensions could be experiencing any or all of the following:

- 1. A rising level of student misbehavior and school disorder;**
- 2. An administrative emphasis on commission of certain targeted offenses; or**
- 3. A building with physical plant or staffing problems that makes effective supervision of student behavior difficult.**

Conversely, a school with a decrease in suspensions could be experiencing any of the following:

- 1. A decrease in the level of student misbehavior and school disorder;**
- 2. A change in automatic suspension requirement (i.e. zero tolerance) for certain school offenses; or**
- 3. The assignment of additional personnel to the school, coupled with a more comprehensive supervision plan.**

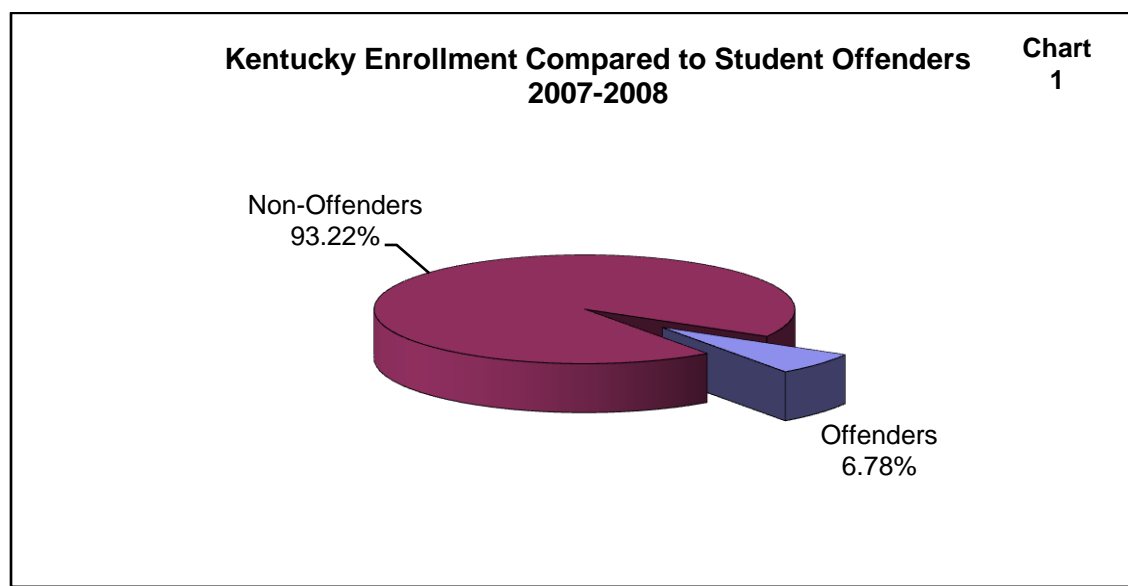
The context should drive the intervention plan.

We encourage school administrators to use the data presented in conjunction with their own school-level STI/IC data to enhance their respective school safety plans. Helpful guidance in this area is included in Appendix F- Using the 2007-2008 Report.

The Safe Schools Data Project collects data from all Kentucky public schools regarding the commission of law and school Board Violations that result in one of four disciplinary actions:

- Suspension
- Corporal punishment
- Expulsion with services, and
- Expulsion without services.

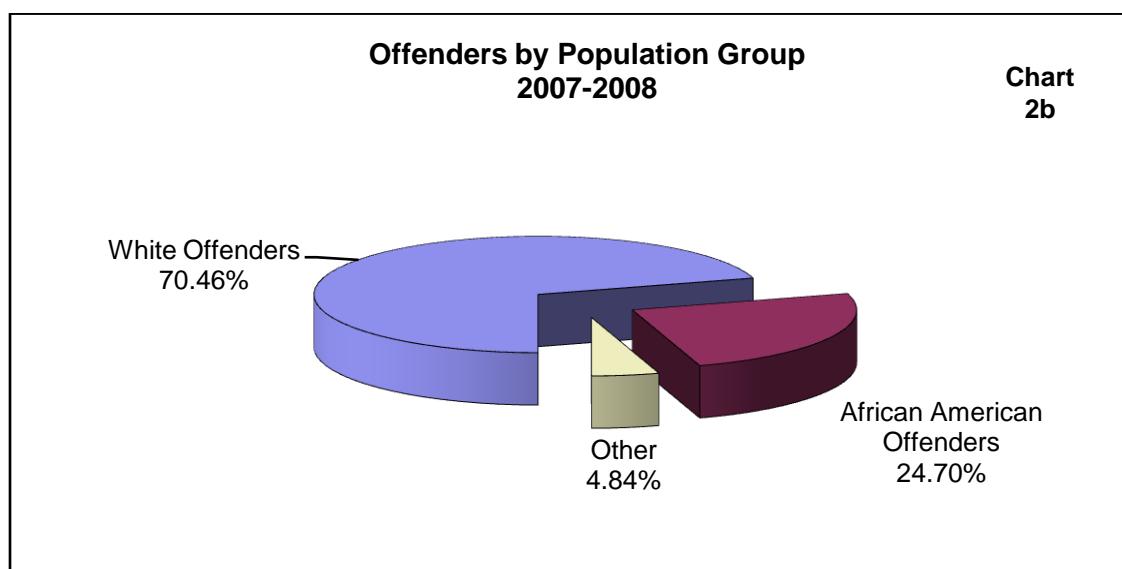
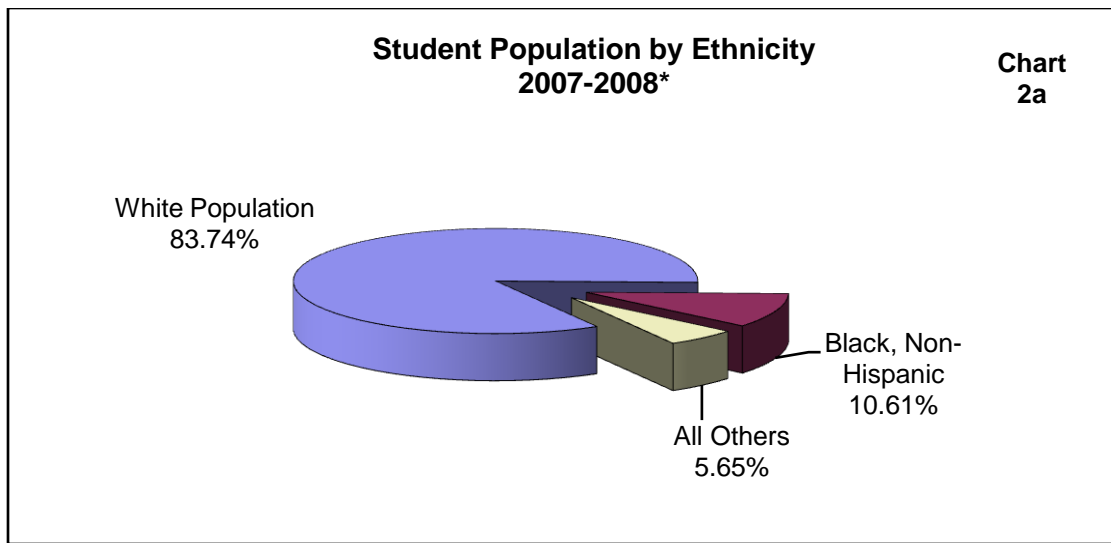
Section II State Level Data*



Kentucky's total public school population for 2007-2008 was 639,719 students. Of that total, only 43,392 students (6.78%) committed an offense that resulted in an out-of-school suspension or an expulsion (with or without services). Lesser disciplinary responses, (e.g., parent conferences, detentions, in-school suspensions) are not reported to the Kentucky Department of Education and are not reflected in this report. In reviewing the upcoming data regarding commission of board and Law Violations, it is very important to keep in mind that 93.22% of Kentucky's students were not offenders and are not represented in the data as illustrated in **Chart 1**.

The term "offender" as used in Charts 1, 2a and 2b refers to an individual student involved in committing at least one incident of prohibited behavior as contained in this report. An offender, however, may commit multiple offenses.

* The enrollment numbers used throughout this report were obtained from the Kentucky Department of Education's Superintendent's Annual Attendance Ethnic Membership Report. These figures best reflect the districts' most stable enrollments.

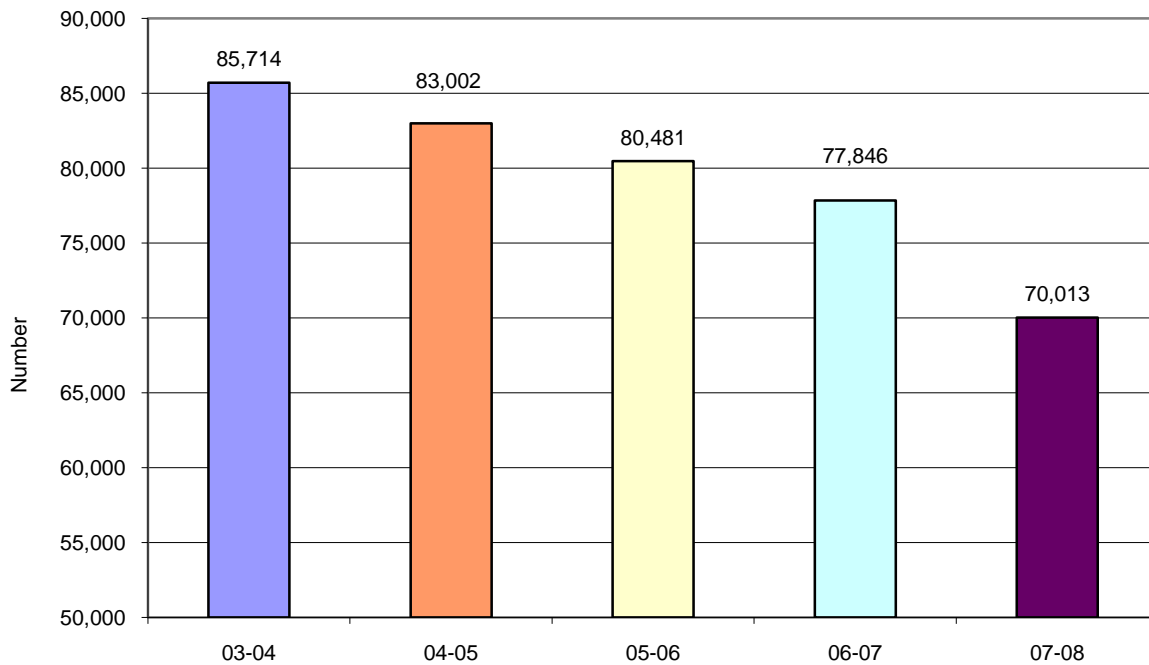
Chart 2a illustrates Kentucky students by ethnicity while **Chart 2b** shows the percentage of offenders by population group. Although White students comprise 83.74% of the total student population, the percentage of white students in the offender group is only 70.46%. On the other hand, Black, non-Hispanic students make up just 10.61% of the total student population, but account for 24.70% of the student offenders. Other ethnic groups represent 5.65% of the total student population and 4.84% of the offender group. The disproportionate representation of Black students in the offender group is consistent with previous Safe Schools Data reports and suggests the need for continued study into reversing this trend.

Disciplinary Actions for Violations of Board Policy In Kentucky Schools

Chart 3 provides the total number of disciplinary actions for 10 categories of school board policy violations for the past five years. The number of disciplinary actions for the 2007-2008 school year decreased 10.1% (or 7,833 actions) from the 2006-2007 total and 18.3% (or 15,701 actions) from the 2003-2004 total. This decline is particularly encouraging because it represents a continuous decline over the five year period under study here.

Disciplinary Actions for Board Violations by Category

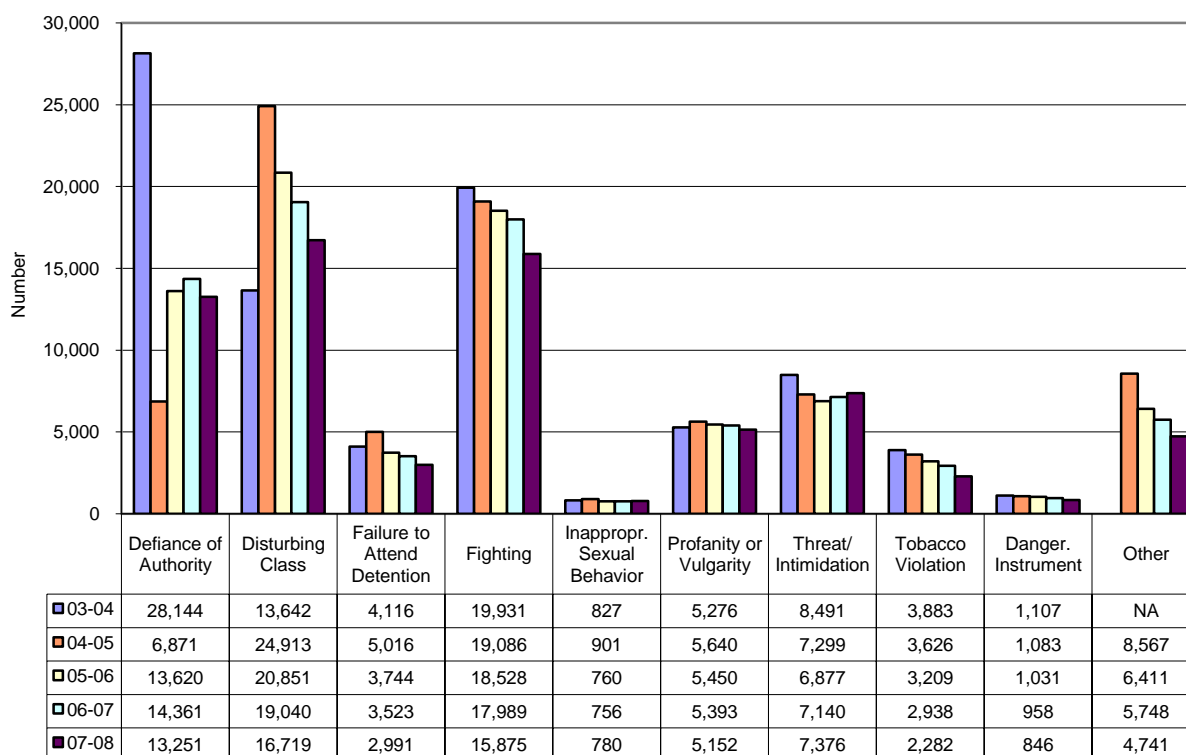
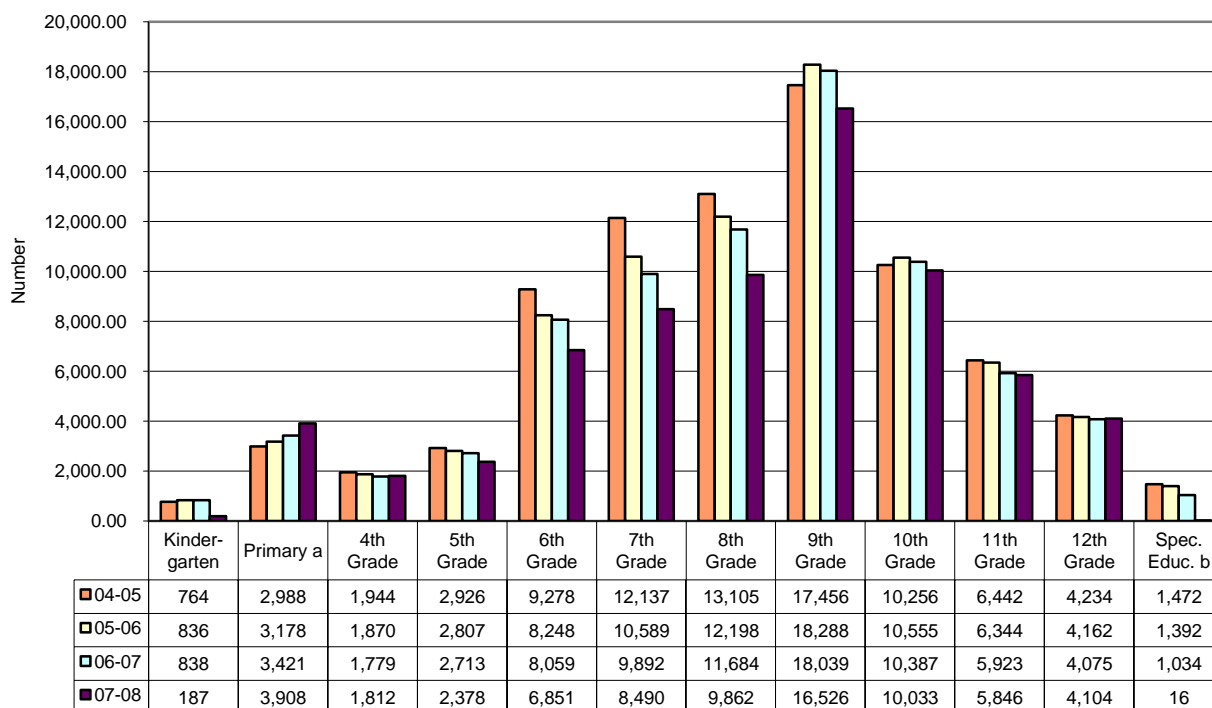

Chart 4 depicts a categorical breakdown of disciplinary actions for board policy violations. The categories showing the biggest change from 2006-2007 were the Tobacco Violations category (a 22.3% decrease), Other Board Violations (a 17.5% decrease), Disturbing Class (with a 12.2% decrease), and Fighting (an 11.8% decrease). With the exception of Threat/ Intimidation (where there was a 3.3% increase) and Inappropriate Sexual Behavior (where there was a 3.2% increase), disciplinary actions for all other categories decreased from 2006-2007 levels, including Failure to Attend Detention (15.1%), Defiance of Authority (7.7%), Profanity or Vulgarity (4.5%), and Dangerous Instruments- Carrying or Using (11.7%). The decrease in Board Violations across all categories (except threat/intimidation and inappropriate sexual behavior) is an especially encouraging feature of the data.

An analysis of the five-year data trends suggests that disciplinary actions for Defiance of Authority (52.9%), Failure to Attend Detention (27.3%), Tobacco (41.2%), Fighting (20.4%), Threat and Intimidation (13.1%), and Dangerous Instruments (23.6%) have decreased substantially over the five-year period. Disciplinary actions for Inappropriate Sexual Behavior and Profanity or Vulgarity have remained relatively stable over the five-year period while Disturbing Class (32.9%) has decreased substantially over four years after what appears to be a peak in those offenses in 2004-05.

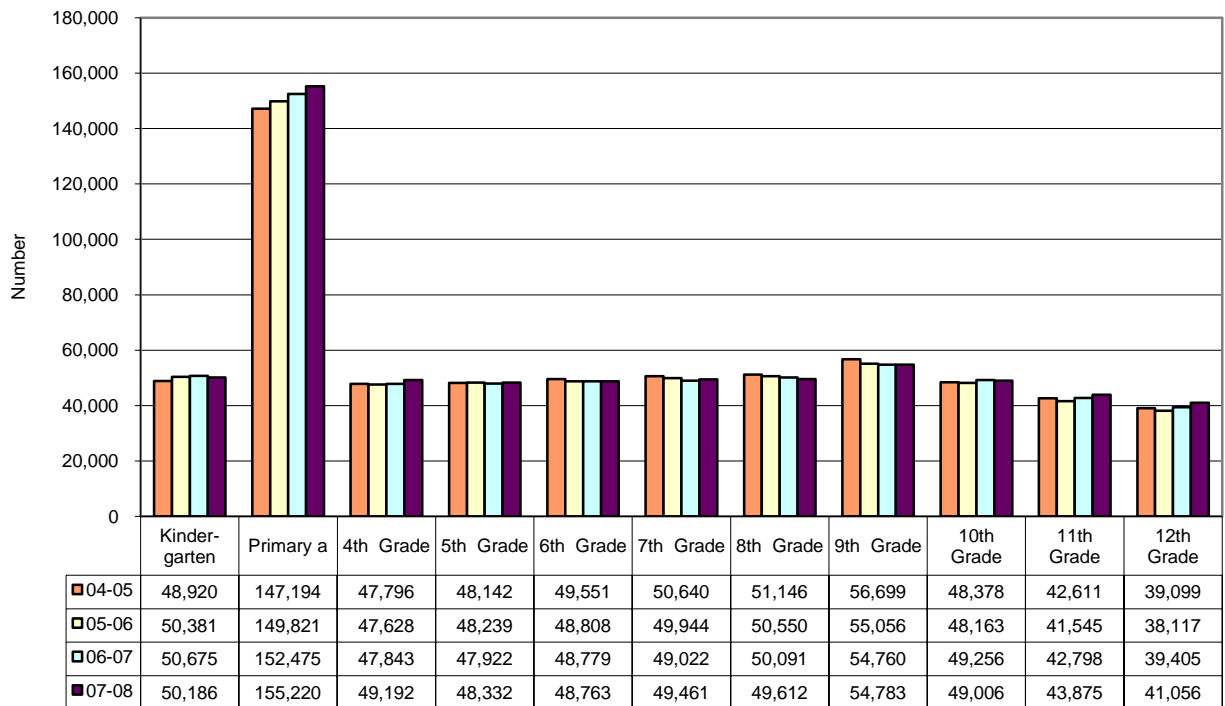

Chart 5a shows the distribution of Board Violations across grade levels. Because we were unable to collect grade-level data prior to 2004-2005, only four years of data are presented. The chart clearly illustrates the increasing number of disciplinary actions from Kindergarten through 9th grade with a concurrent decreasing number of actions from 10th grade through 12th grade in each of the four years under study. In 6th grade, which typically marks the transition from elementary to middle school, the number of disciplinary actions is almost four times the number for 5th graders in each of the three years. Although the data presented here do not allow us to identify the causes of the increase between 5th and 6th grade, one possible explanation for this increase has to do with the more punitive philosophies of middle school administrators and teachers when compared with their colleagues in elementary school. Because this report only includes disciplinary actions that involve out-of-school suspensions, expulsions, and corporal punishments (used in 52 districts), it may be that the rule-breaking activity that received an office referral or some other in-school punishment in 5th grade (the highest grade in most Kentucky elementary schools) may receive an out-of-school suspension in 6th grade (the lowest grade in most Kentucky middle schools). Regardless of the explanation, this increase needs to be further explored, as does the large increase between 8th and 9th grades (33.2% in 2004-2005, 49.9% in 2005-2006, 54.4% in 2006-2007, and 40.3% in 2007-2008), the typical transition year from middle to high school.

Total Enrollment by Grade ^a

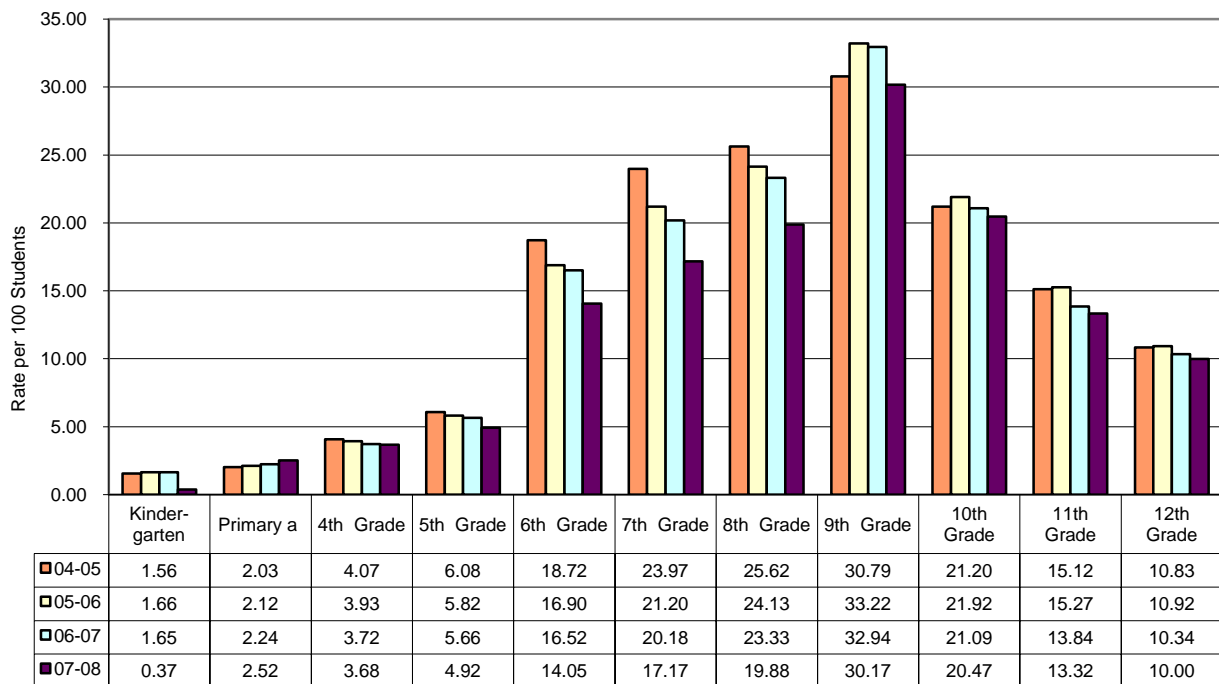

Chart 5b depicts the enrollment for grades 4-12 while **Chart 5c** shows the rate of violations per 100 students for grades 4-12 from 2004-2005 to 2007-2008. Part of the decrease in disciplinary actions from 10th through 12th grades is due to the declining population at each grade level; however, because the population of sixth through eighth grades remained relatively constant, the large increases during these grades are very troubling and suggest the need for more research into intervention strategies that will curtail this trend.

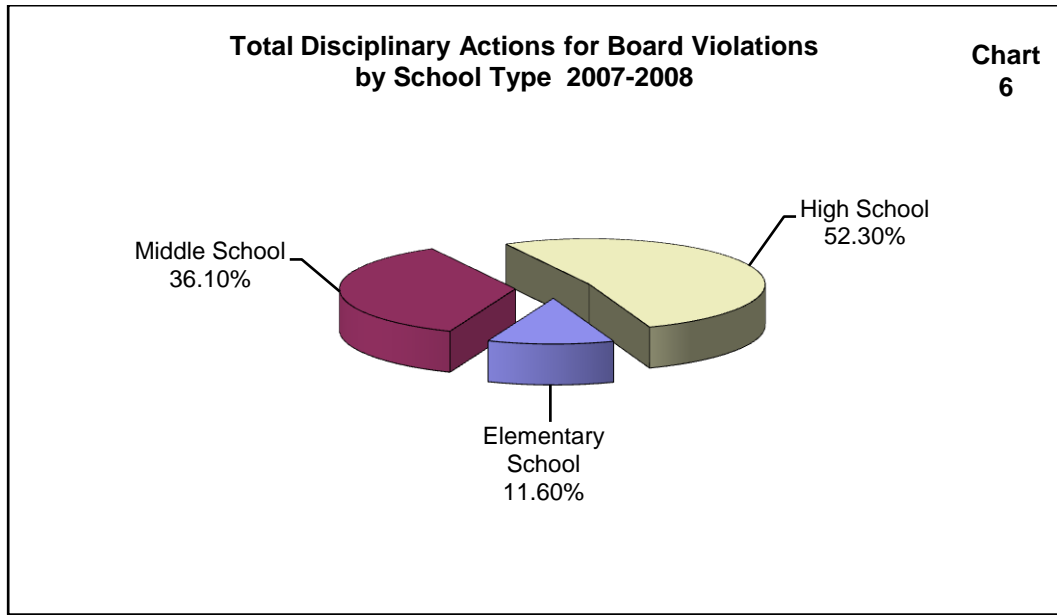


Chart 6 indicates that elementary schools represent 11.60% of the total Board Violations while disciplinary actions for Board Violations in middle and high school account for 36.10% and 52.30% of all disciplinary actions, respectively. Although the largest percentage of Board Violations occurs at the high school level, there are four grades, 9th-12th, at the high school level and only three grades, 6th-8th, at the middle school level. Previously, **Chart 5a** specifies the violations by grade level, which shows that of the five grades with the highest violations, three were in middle school.

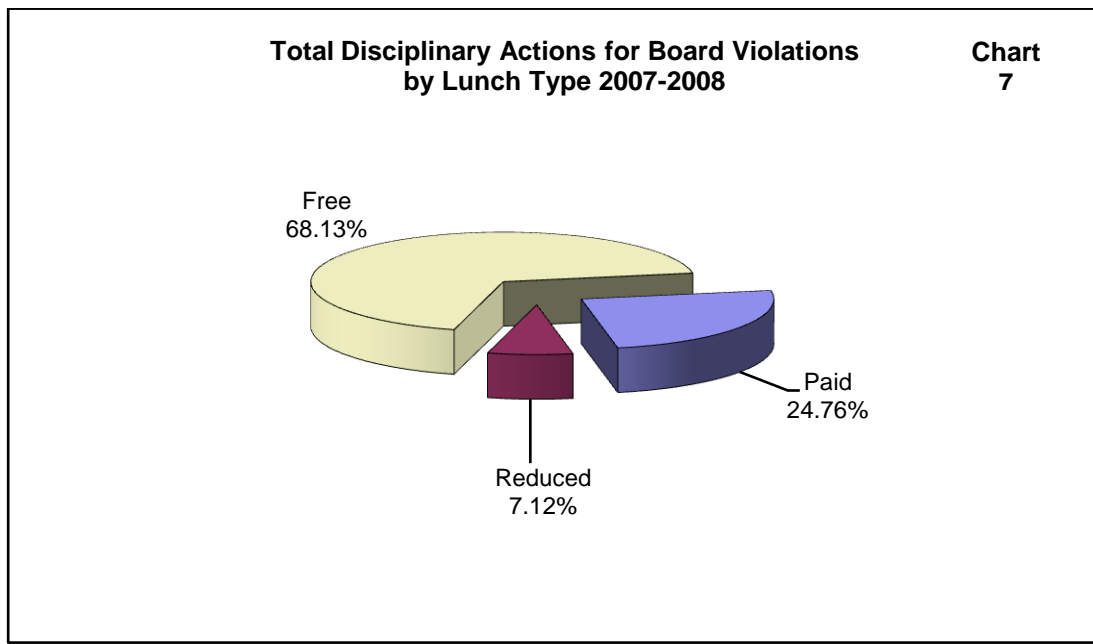
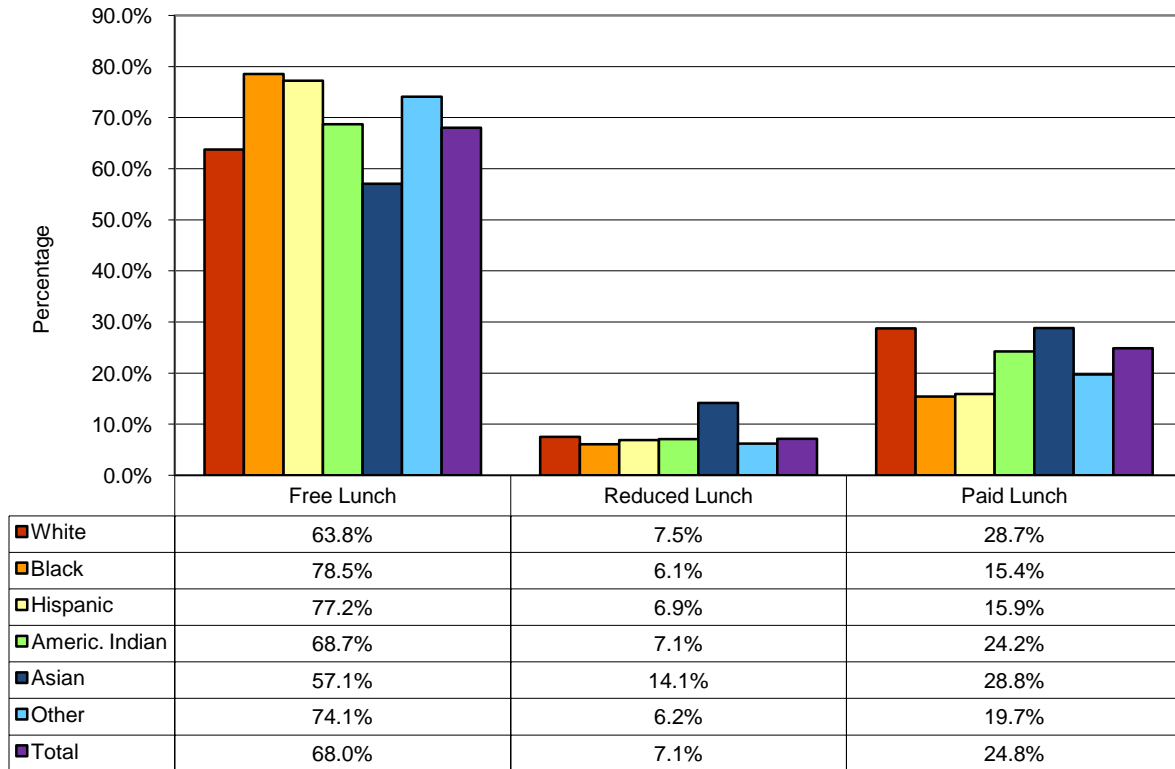


Chart 7 illustrates the total disciplinary actions for Board Violations by lunch type. Students who qualified for free lunch comprised 68.13% of the total disciplinary actions while students with paid and reduced lunches accounted for 24.76% and 7.12% of the total disciplinary actions, respectively. For the 2007-2008 school year, approximately half of Kentucky's students received free or reduced lunches (see <http://www.kyschools.org/KDE/HomePageRepository/News+Room/Kentucky+Education+Facts.htm>)

Among the student offenders, the percentage of students who qualified for free or reduced lunch (75.25%, or the sum of 68.13% and 7.12% from Chart 7) is considerably higher than their representation in the total population. It is quite possible that this link may be due to a number of factors not measured in these data (e.g., the reduced parental involvement in school activities often seen in low-income households, additional stressors faced by students from low-income households) rather than a direct relationship between household income and school behaviors. In any case, the link between poverty and school misbehavior is an area that needs additional study.

Board Violations by Lunch Type and Race - 2007-2008 School Year

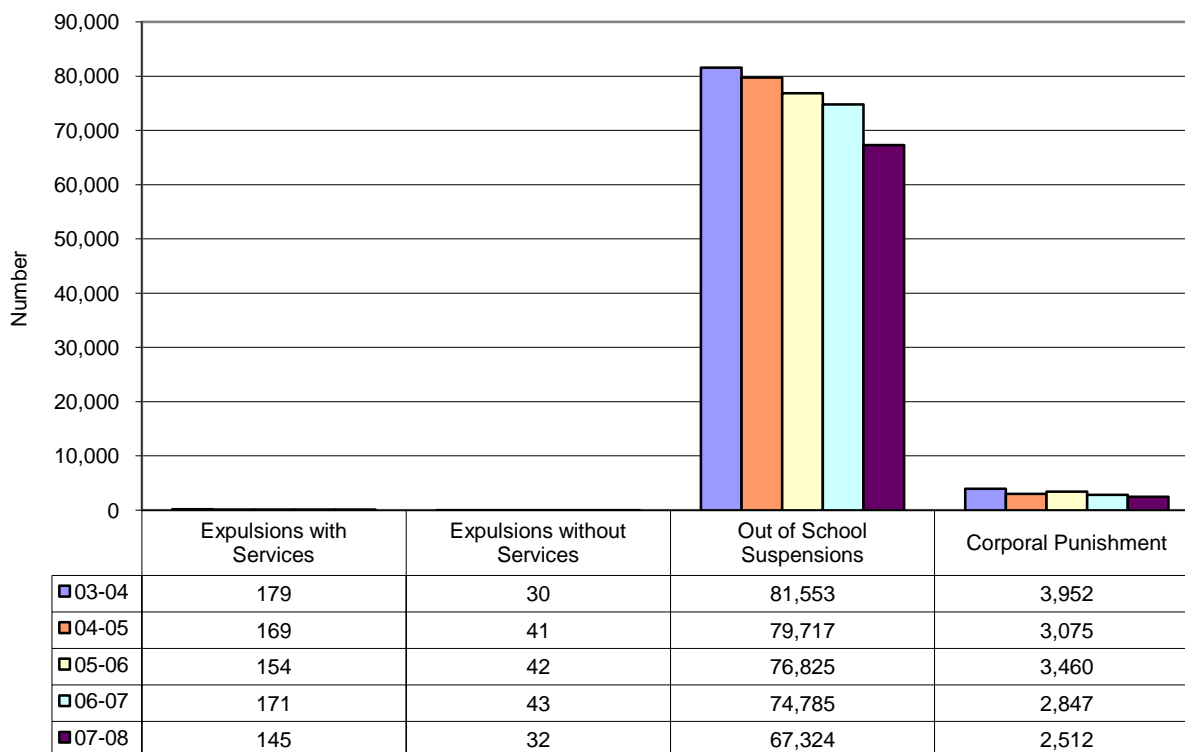

Disciplinary actions for Board violations are displayed by race and lunch category in **Chart 8**. The percentage of Blacks, Hispanics, and Others that were given disciplinary actions for board violations that received free lunch (78.5%, 77.2%, and 74.1%, respectively) was substantially higher than the percentage of Whites that were given disciplinary actions for Board violations that received free lunch (63.8%). As such, it appears that both race and free lunch status impact the likelihood of receiving disciplinary actions for Board violations in 2007-2008.

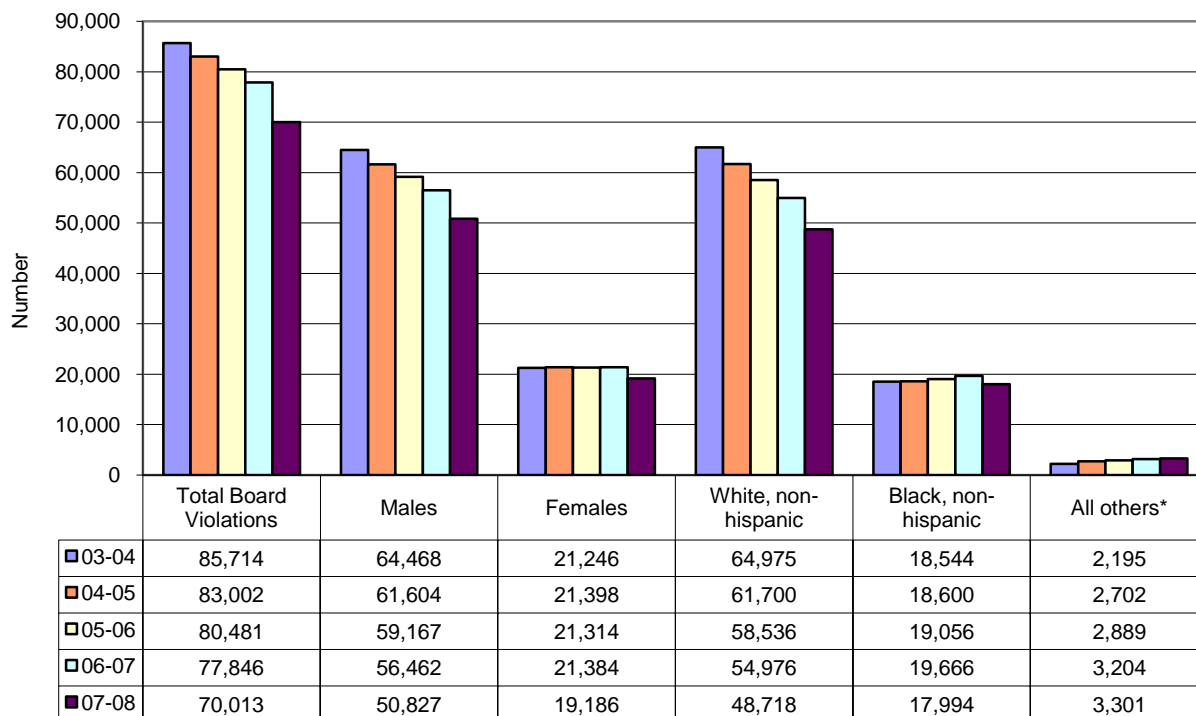


Total Board Violations are categorized by specific disciplinary actions in **Chart 9**. In 2007-2008, there were 7,461 fewer out-of-school suspensions than the previous year, a decrease of 10.0 percent. At the same time, there were 26 fewer incidents of expulsions with services (a 15.2% decrease), 11 fewer expulsions without services (a 25.6% percent decrease), and 335 fewer incidents of corporal punishment (an 11.8% decrease). Compared to out-of-school suspensions, expulsions (both with and without service) occur relatively infrequently; the total number of expulsions without services remained below 50 for the entire state for the sixth consecutive year.

Over the five-year period, the number of expulsions without services throughout the state has remained relatively stable (between 30 and 43). Additionally, three important trends have emerged. First, out-of-school suspensions for Board Violations appear to have steadily declined (17.4% over the past five years). Second, corporal punishments appear to have begun a downward trend in 2005-2006 (decreasing 36.4% over the five-year period, with a slight increase between 2004-2005 and 2005-2006). Finally, expulsions with services also have declined over the five-year period (a decrease of 19.0% over the past five years). Each of these findings is encouraging. The number of expulsions without services for Board Violations (ranging between 30 and 48) has remained relatively stable over the five-year period.

Board Violations by Population Group



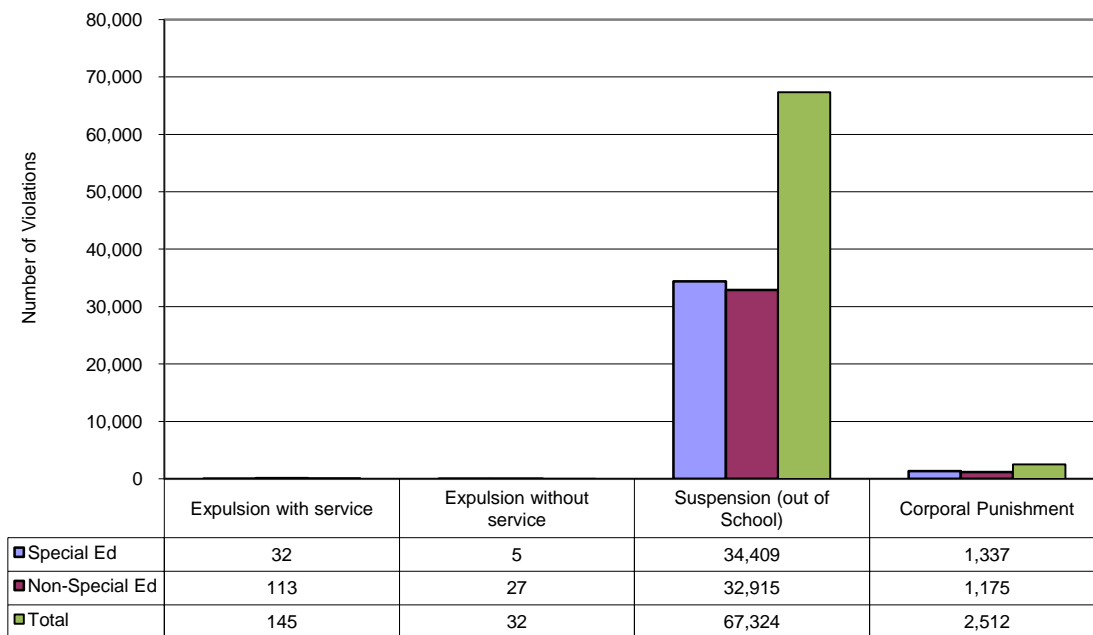

Comparisons of disciplinary actions by gender and ethnicity are made in **Chart 10**. Between 2006-2007 and 2007-2008, total disciplinary actions for Board Violations for males (10.0%) declined, as did disciplinary actions for White, non-Hispanics (11.4%), females (10.3%), and non-Hispanic Blacks (8.5%). Disciplinary actions for "All Others" increased slightly (3.0%) over the two-year period. The ratio of male violations to female violations is almost 3:1 and is consistent with previous data.

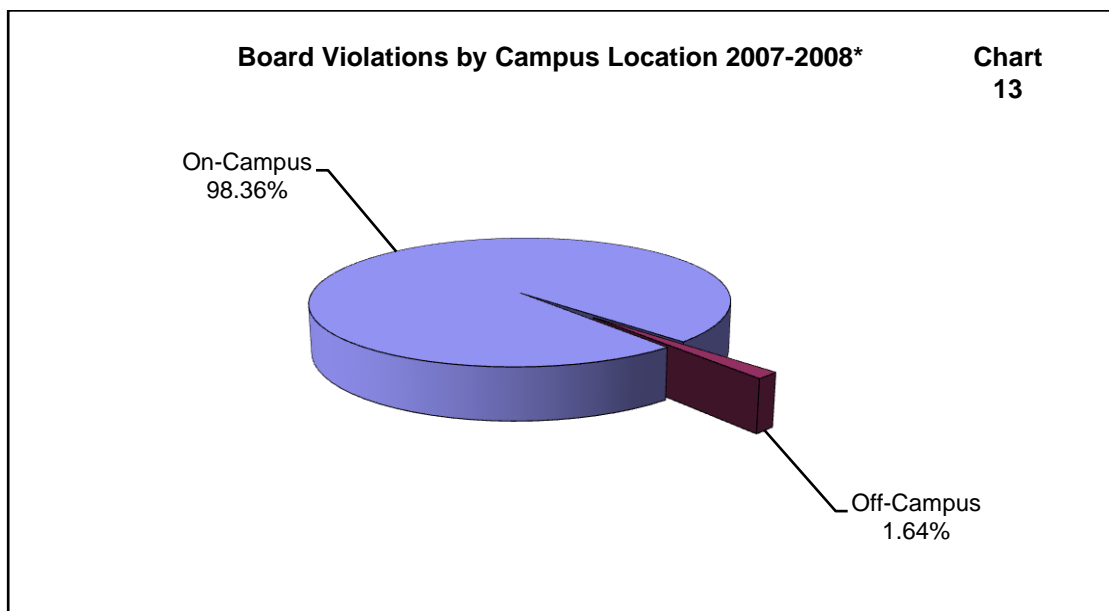
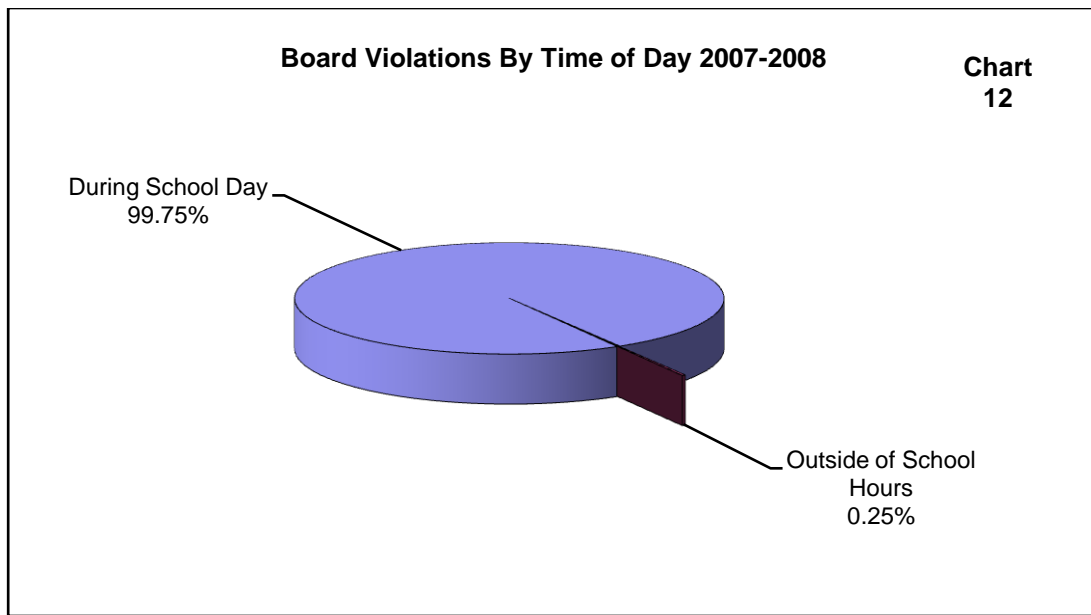
A comparison of disciplinary actions over the five-year period suggests several trends. First, total disciplinary actions for Board Violations, disciplinary actions for males, and disciplinary actions for White, non-Hispanics appear to have peaked in 2003-2004 and have now begun a downward trend (decreases of 18.3%, 21.2%, and 25.0% from 2003-2004 to 2007-2008, respectively). Secondly, disciplinary actions for females and Black, non-Hispanic students have remained relatively stable over the five year period. Finally, disciplinary actions for students of all races other than White or Black have increased dramatically (50.4%) over the five-year period. During that same period, the number of total students in public schools in Kentucky in the "All Others" category increased by 34.5%, so the dramatic increase in disciplinary actions for board violations cannot be fully explained by the population increase in that group. Additional research is needed to fully understand this increase.

For the first time in 2007-2008, we are able to distinguish those students who had an IEP from those that did not. The comparison of disciplinary actions by IEP status is presented in **Chart 11**. The results presented in **Chart 11** suggest that approximately one in five students (18.1%) receiving an expulsion with service for a Board violation had an IEP in 2007-2008 while a slightly smaller percentage (13.5%) of those receiving expulsions without service had an IEP. One in three students who were suspended or received a corporal punishment for a Board violation in 2007-2008 (33.82% and 34.74%, respectively) had an IEP. Given that approximately one in five (17.1%) students in public schools in Kentucky had an IEP in 2007-2008, both the percentages for out-of-school suspensions and corporal punishments suggest that students with IEPs are disproportionately more likely to receive those disciplinary actions for Board violations.

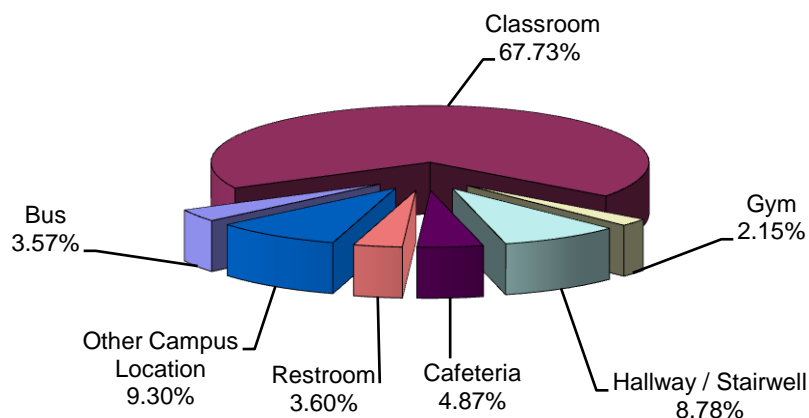

Charts 12 and 13 depict the time of day and location of board policy violations. The charts reflect that 99.75% of Board Violations are committed during the school day and 98.36% are committed on school campus.

The location of the commission of board policy violations is further separated in **Chart 14**. The classroom is the site of the majority of Board Violations (67.73%). The remaining Board Violations are committed in other campus locations (9.30%), hallways/stairwells (8.78%), restrooms (3.60%), the cafeteria (4.87%), on the bus (3.57%), and in the gymnasium (2.15%). These trends have been fairly stable for each time period for which we have data.

Note: Public schools are legally responsible for the behavior and safety of students when they leave their homes to go to school until they return to their homes after their school day is over.

Law Violations that are committed by a student outside of the school day are subject to consequences imposed by the justice system and are not recorded in these data.

Law Violations committed during the school day are subject to consequences imposed by the school district and are included in this report. When the Law Violation during the school day is of a severe nature, the justice system may also be involved.

Disciplinary Actions for Law Violations in Kentucky Schools

At the beginning of this reporting process in 1998, the Kentucky Department of Education adopted the FBI Uniform Crime Reporting (UCR) Form as a format for reporting Law Violations on school grounds and at school-related activities. Under this system, *Part I* crimes involve an illegal act directed against a person or property and are generally considered to be more serious offenses. *Part II* Law Violations may result in an arrest, but are considered less serious. Definitions of *Part I* and *Part II* crimes can be found in **Appendix A**. The following charts show the reported incidents of *Part I* and *Part II* Law Violations from 2003-2008.

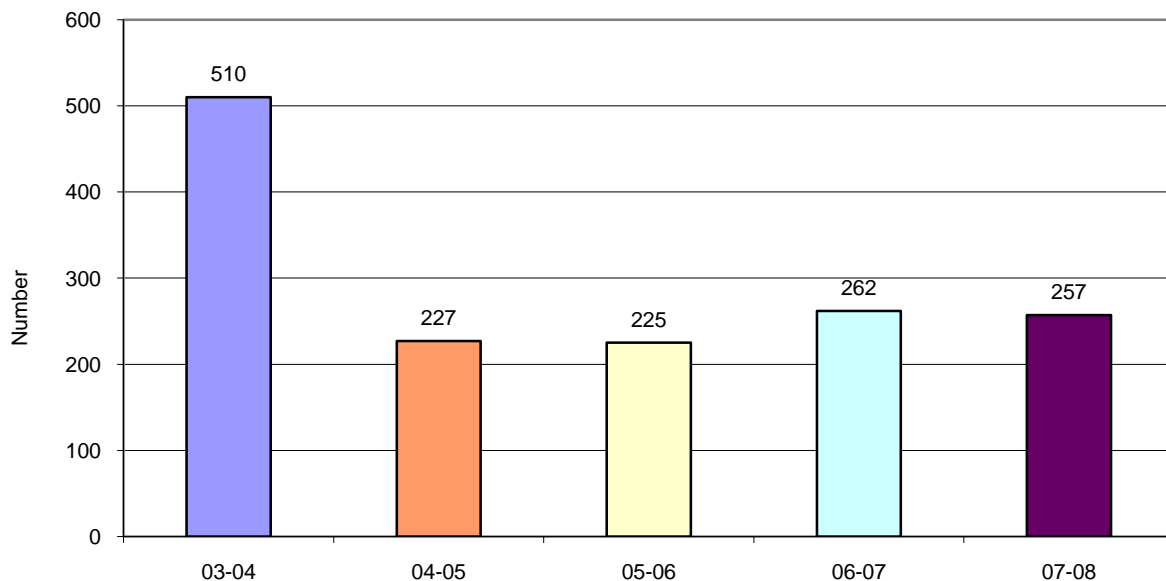
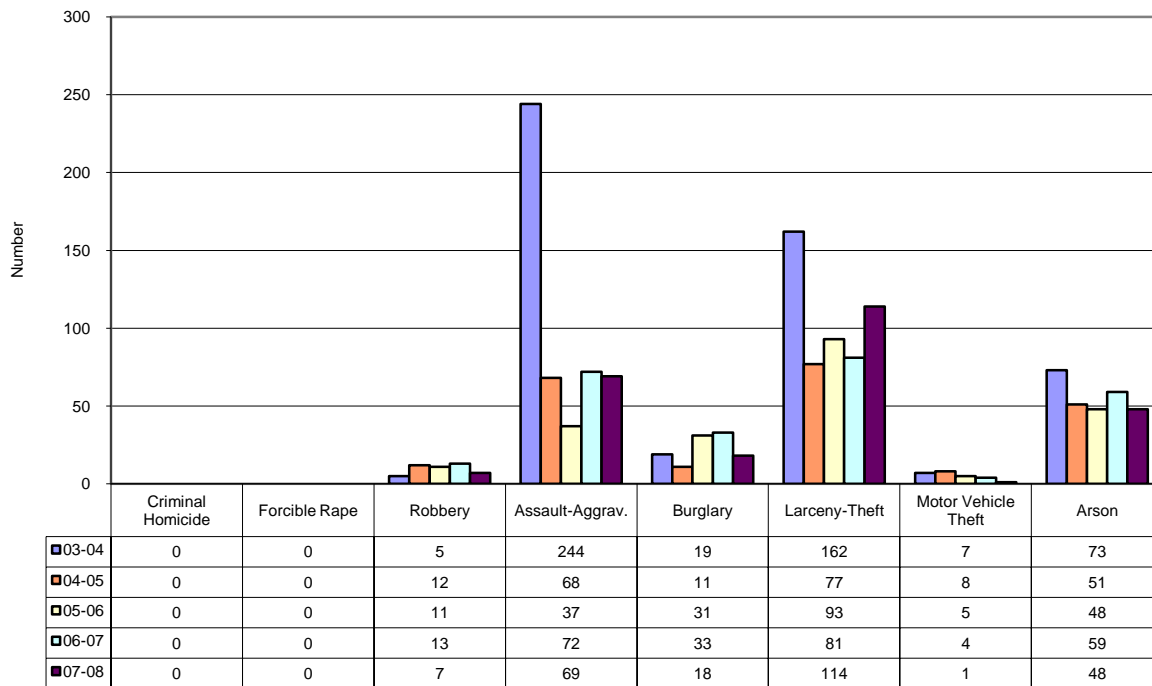


Chart 15 illustrates a dramatic five-year decline in disciplinary actions for *Part I* Law Violations. Despite the slight increase (16.44%) in Law Violations that occurred from 2005-2006 to 2006-2007, disciplinary actions for *Part I* Law Violations declined 49.6% over the five years under study. Because *Part I* Law Violations are considered more serious than *Part II* Law Violations, the substantial decrease over the five-year period is encouraging and suggests that fewer serious Law Violations are being committed at school. Nevertheless, the slight increase in *Part I* Law Violations for 2006-2007 and the relative stability of that number from 2006-2007 to 2007-2008 suggests that this finding should be monitored closely to determine if this increase is the beginning of an upward trend or a finding unique to only those two years.

Disciplinary Action for Part I Law Violations by Category

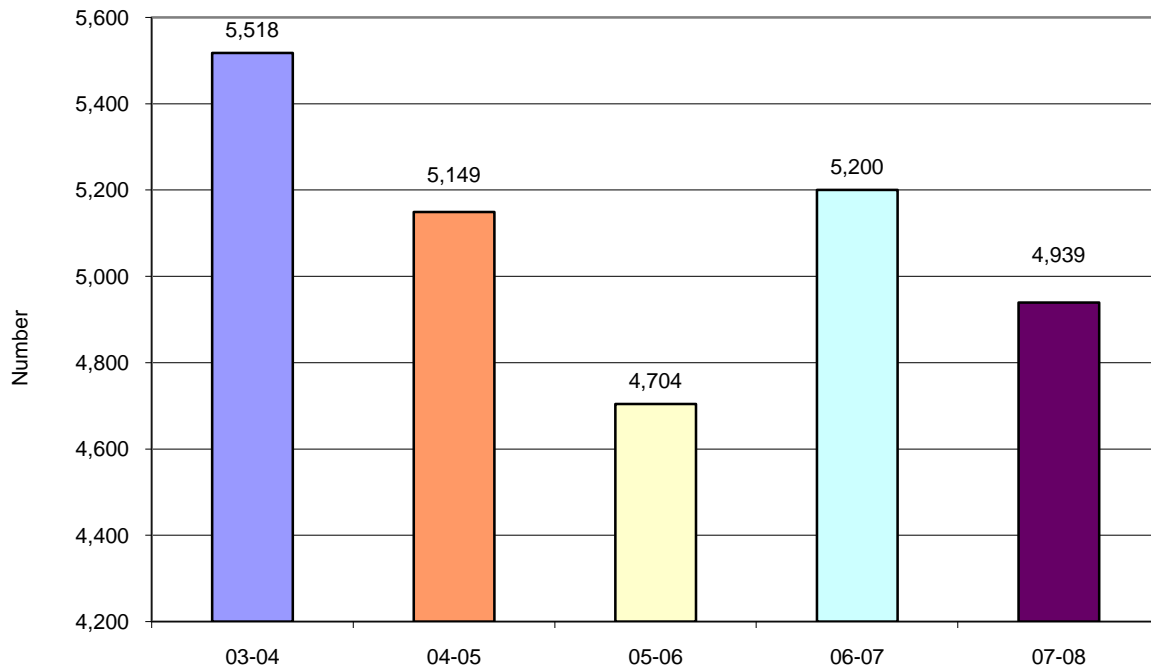

Note that a slight change in a single or double digit number can have a dramatic impact on percentages.

Disciplinary actions for *Part I* Law Violations by category are shown in **Chart 16**. Over the five-year period, aggravated assaults (71.7%), larceny-theft (29.6%), and arson (34.2%) decreased dramatically. Disciplinary actions for motor-vehicle theft and burglary fluctuated during the five-year period, but remained at ten or less incidents throughout the state for motor vehicle theft and 35 or less incidents for burglary throughout the entire five-year period. Despite these encouraging findings, robbery increased 40.0% over the five-year period (but there were only seven reported robberies in 2007-2008 throughout the state). The downward trend in aggravated assault (coupled with the fact that there were no criminal homicides or forcible rapes reported over the five-year period) is a promising development and is even more encouraging when combined with the concurrent decrease in aggressive behaviors (i.e., fighting, threat/intimidation, and dangerous instruments) noted in disciplinary actions for board policy violations (**Chart 4**).

Total Disciplinary Actions for Part II Law Violations

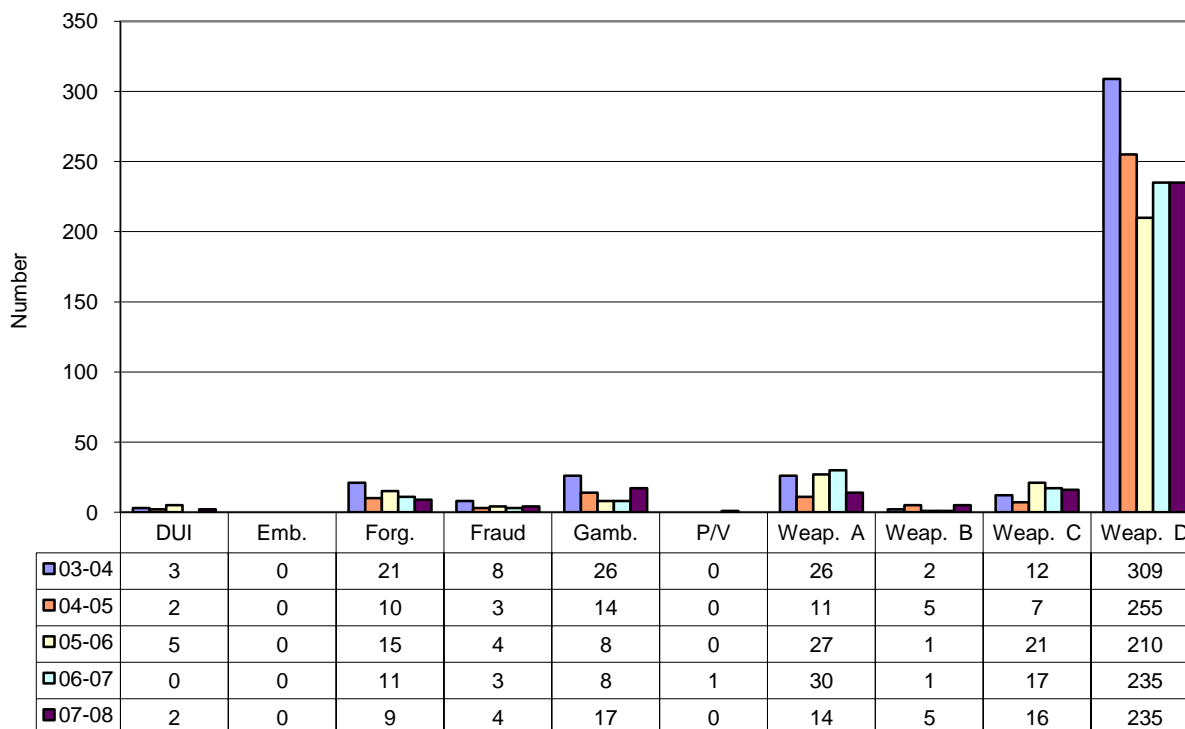

In **Chart 17**, the total disciplinary actions for *Part II* Law Violations are presented. Disciplinary actions for *Part II* Law Violations decreased by 5.0% from 2006-2007 to 2007-2008 and by 10.5% over the five-year period. While this is a more modest decrease than reported for *Part I* Law Violations, the total cases of *Part II* Law Violations in 2007-2008 is approximately 20 times the number of *Part I* Law Violations for the same year. The declining number of disciplinary actions for both *Part I* and *II* Law Violations over the five-year period remains a promising trend.

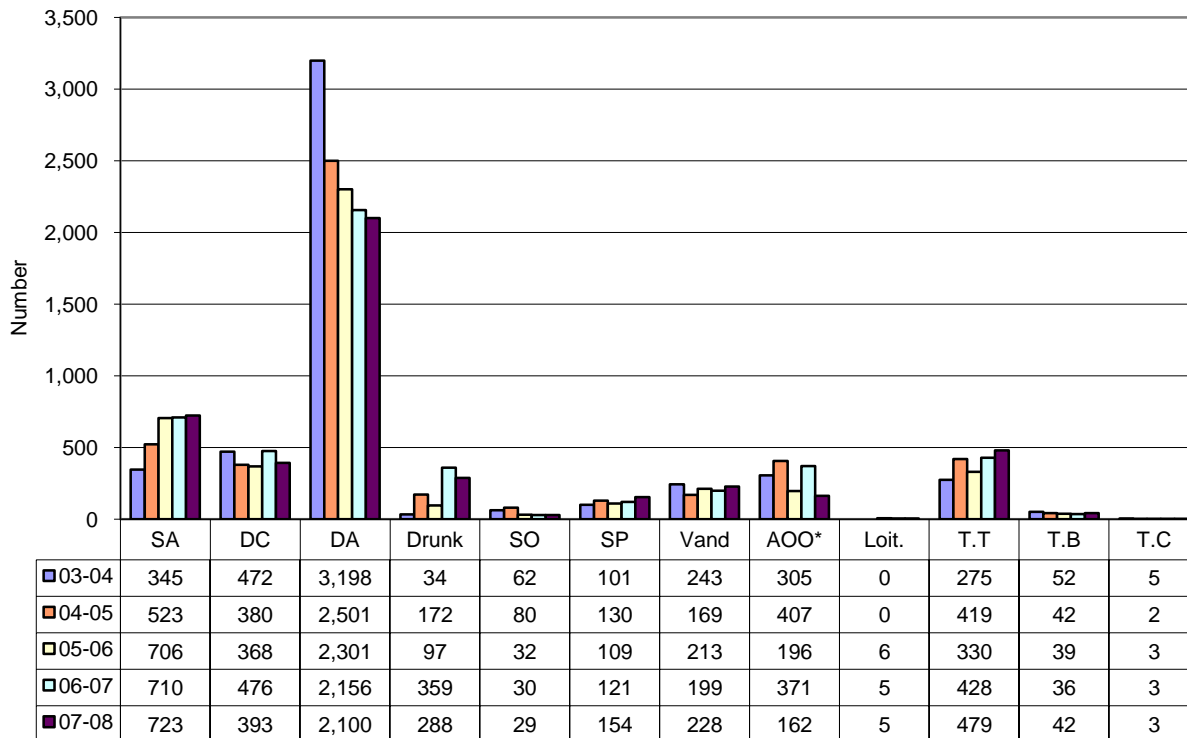

The depiction of *Part II* Law Violations by category requires two charts to display results. **Chart 18** reveals disciplinary actions for 12 of the 25 less serious categories of Law Violations for which data are collected. With the exception of driving under the influence (where numbers remained relatively stable), over the five-year period, all disciplinary actions that did not involve weapons declined significantly. Relatively few disciplinary actions occur annually for each of these categories. Additionally, disciplinary actions for Weapon A- Handguns, Weapon B- Rifles, and Weapon C- Other Firearms remained relatively stable over the five-year period while disciplinary actions for Weapon D- All Other Weapons declined 24.0% over the five-year period.

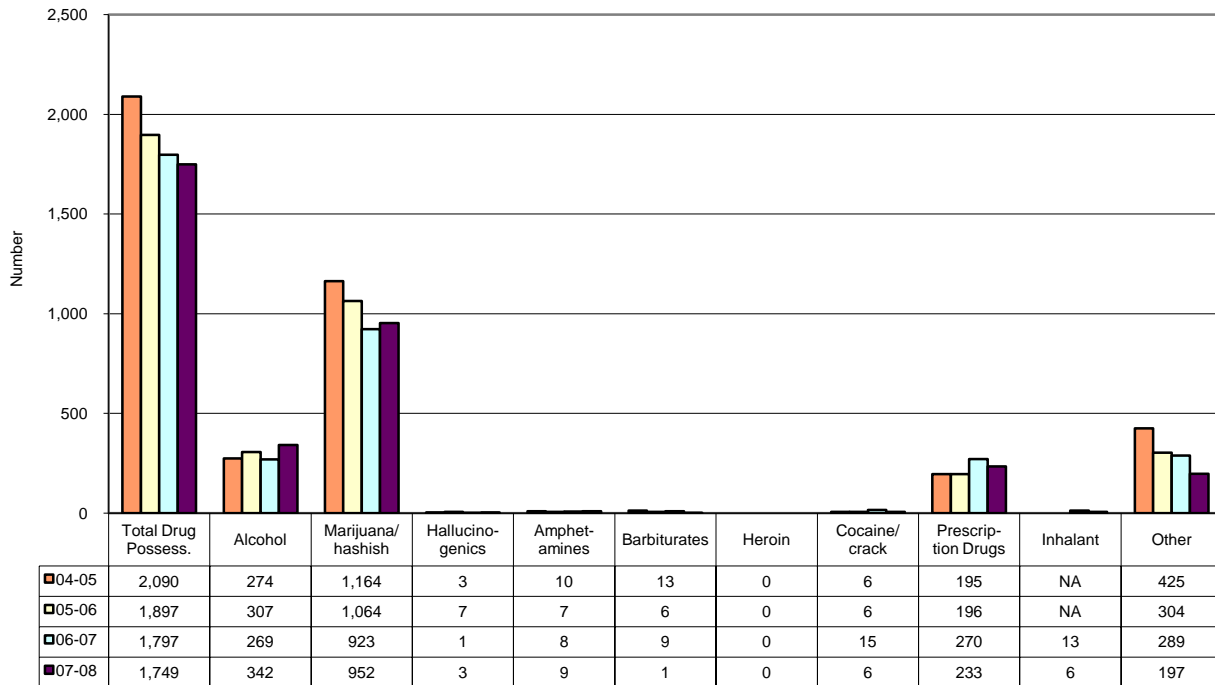

Chart 19 depicts disciplinary actions for the remaining 13 categories of *Part II* Law Violations. During the five-year reporting period, there were significant decreases in a number of disciplinary actions for Law Violations, including drug abuse (34.3%), sex offenses (53.2%), terroristic-chemical/biological/nuclear (40.0%), disorderly conduct (16.7%), and all other offenses (46.9%). Nevertheless, not all Law Violations in the chart declined dramatically throughout the five-year period. Although the number of disciplinary actions for simple assault increased 109.6% over the five-year period, most of that increase occurred between 2003-2004 and 2005-2006; since that time, the number of disciplinary actions for simple assault has remained relatively stable. Disciplinary actions for drunkenness increased 747.1% over the five year period, but again, most of this increase occurred between 2005-2006 and 2006-2007. In fact, the number of disciplinary actions for drunkenness decreased 19.8% from 2006-2007 to 2007-2008. Receiving stolen property increased dramatically over the five-year period (52.5%) and 27.3% between 2006-2007 and 2007-2008. The number of disciplinary actions for vandalism, loitering, and terroristic – bomb threatening remained relatively stable over the five-year. Terroristic threatening increased 74.2% over the five-year period and 11.9% between 2006-2007 and 2007-2008.

Beginning in 2004-2005, changes to the data collection process allowed us to disaggregate (1) drug possession/use and distribution of illegal drugs and (2) the type of drug for which disciplinary actions were received. **Charts 20 and 21** display the number of disciplinary actions reported for nine drug categories from 2004-2005 to 2007-2008. Overall, disciplinary actions for drug possession/use decreased 16.3% over the four year period. Despite the fact that disciplinary actions for marijuana/hashish possession accounted for over half of all disciplinary actions for drug possession/use each year, disciplinary actions for marijuana/hashish possession/use (18.2%) and other drugs (53.6%) declined substantially over the four-year period. The category “Other” refers to substances not otherwise specified, for example, “designer” drugs such as Ecstasy, or “look-alikes,” and comprised 11.3% of the total possession and use violations in 2007-2008. Thus, disciplinary actions for the two categories that make up the largest percentage of the total drug possession/use category both declined over the four-year period. Disciplinary actions for barbiturates declined dramatically over the four-year period as well (92.3%). Disciplinary actions for amphetamines, cocaine/crack, hallucinogenics, and heroin together make up a very small percentage of drug abuse violations and disciplinary actions for these drugs fluctuated slightly over the four-year period, although none of these drugs had more than 15 disciplinary actions in any of the four years under study. Disciplinary actions for prescription drug possession/use increased 19.5% over the four-year period but decreased 13.7% from 2006-2007 to 2007-2008. Disciplinary actions for alcohol violations increased 24.8% over the four-year period and 27.1% between 2006-2007 and 2007-2008. This finding is a cause of some concern and further research into its explanation is needed.

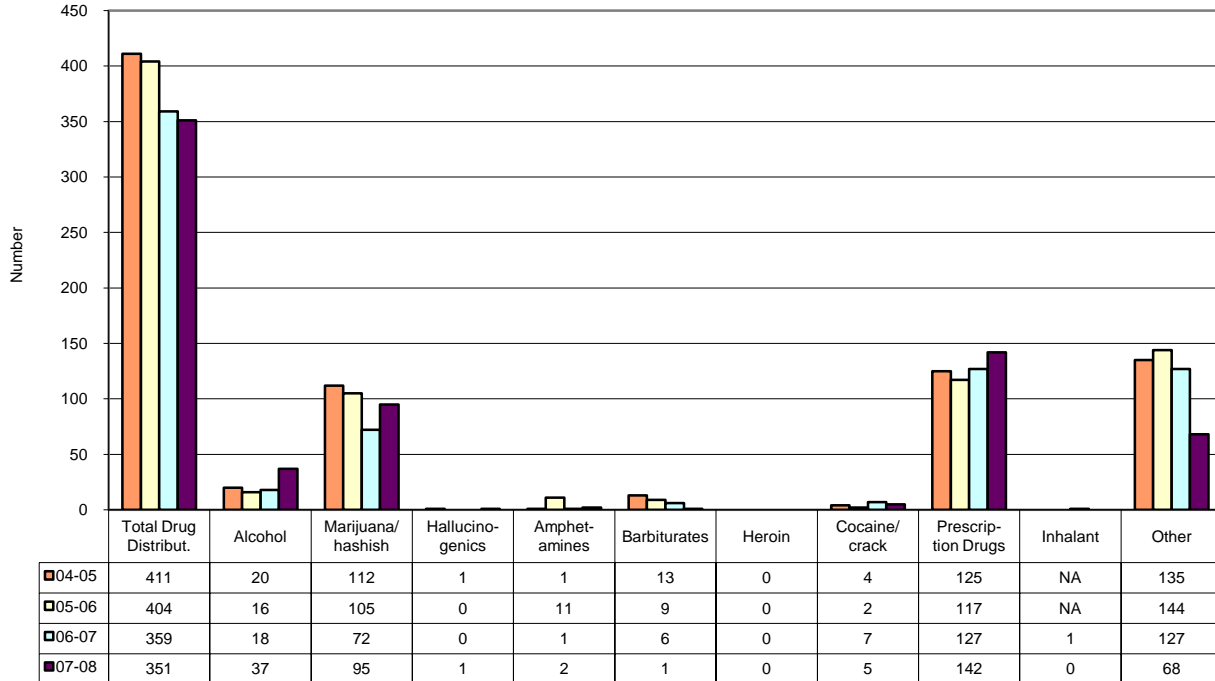
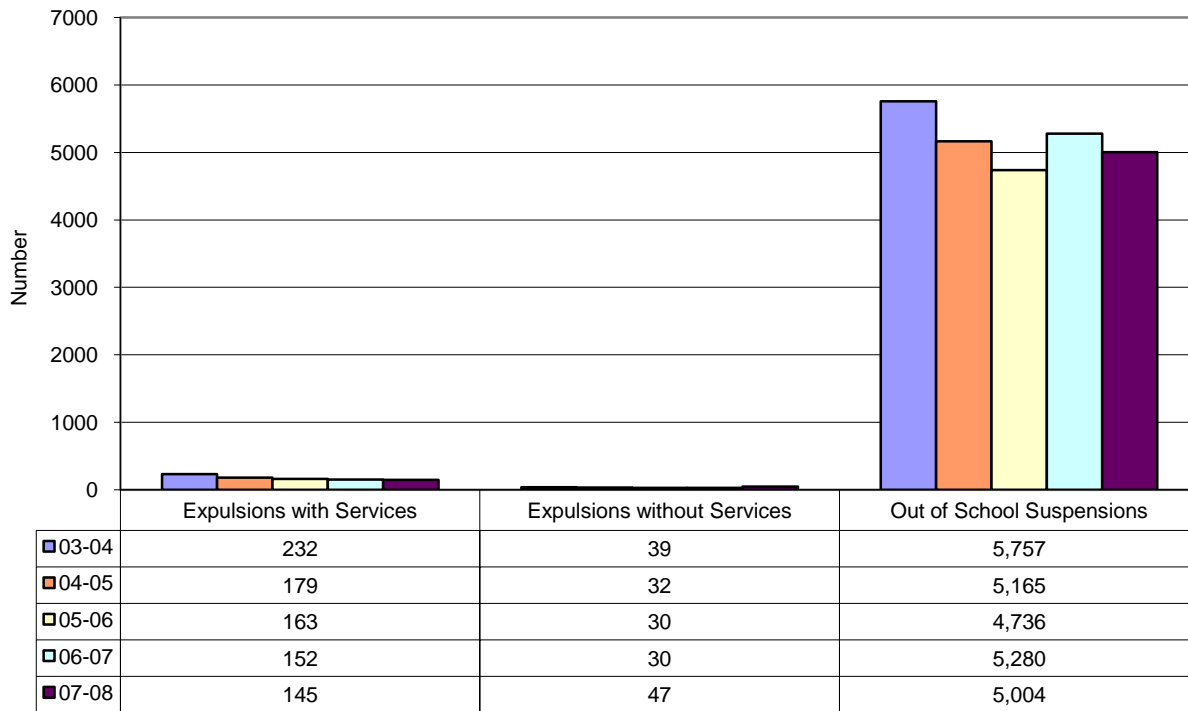


Chart 21 reveals the number of disciplinary actions for drug distribution for the 2004-2005 to 2007-2008 school years. Disciplinary actions for drug distribution declined slightly (14.6%) over the four-year period; this trend was also reflected in decreases in disciplinary actions for marijuana/hashish (15.2%), barbiturates (83.3%), and other drugs (49.6%) over the four-year period. These types of drugs comprised almost half of the disciplinary actions for drug distribution in 2007-2008. Disciplinary actions for prescription drugs increased slightly (13.6%) over the four-year period and also comprised 40% of the total disciplinary actions for drug distribution. The number of disciplinary actions for hallucinogenics, amphetamines, heroin, cocaine/crack, and inhalants remained relative stable over the four-year period. As with possession and use, disciplinary actions for alcohol distribution increased dramatically both over the four-year period (85.0%) and between 2006-2007 and 2007-2008 (105.6%). This finding is also a cause for concern and needs to be further explored.

Law Violations Comparison of Disciplinary Actions

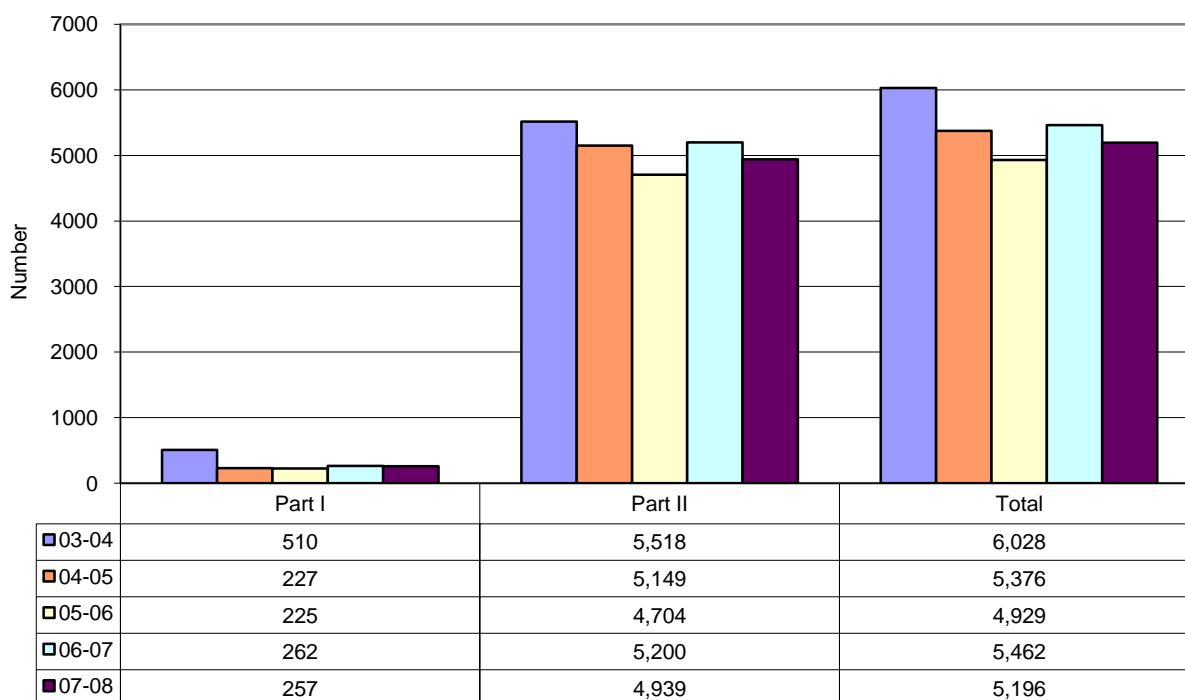

The types of disciplinary actions for all Law Violations are compared in **Chart 22**. Expulsions with Services decreased 37.5% and Out of School Suspensions decreased 13.1% over the five-year period; both also decreased between 2006-2007 and 2007-2008 (4.6% for Expulsions with Services and 5.2% for Out of School Suspensions). Each of these findings is encouraging and indicates a substantial decrease in the number of Law Violations occurring on school property over the last five years. On the other hand, Expulsions without Services increased 20.5% over the five-year period and 56.7% from 2006-2007 to 2007-2008 after remaining relatively stable from 2003-2004 to 2006-2007. Although the number of students throughout the state that received expulsions without services is still less than 50 for the entire state, it remains somewhat discouraging that this number has increased over the five-year period. Further exploration into the causes of this increase may be needed to uncover why this has occurred.

(Combination of Expulsions & Suspensions)**

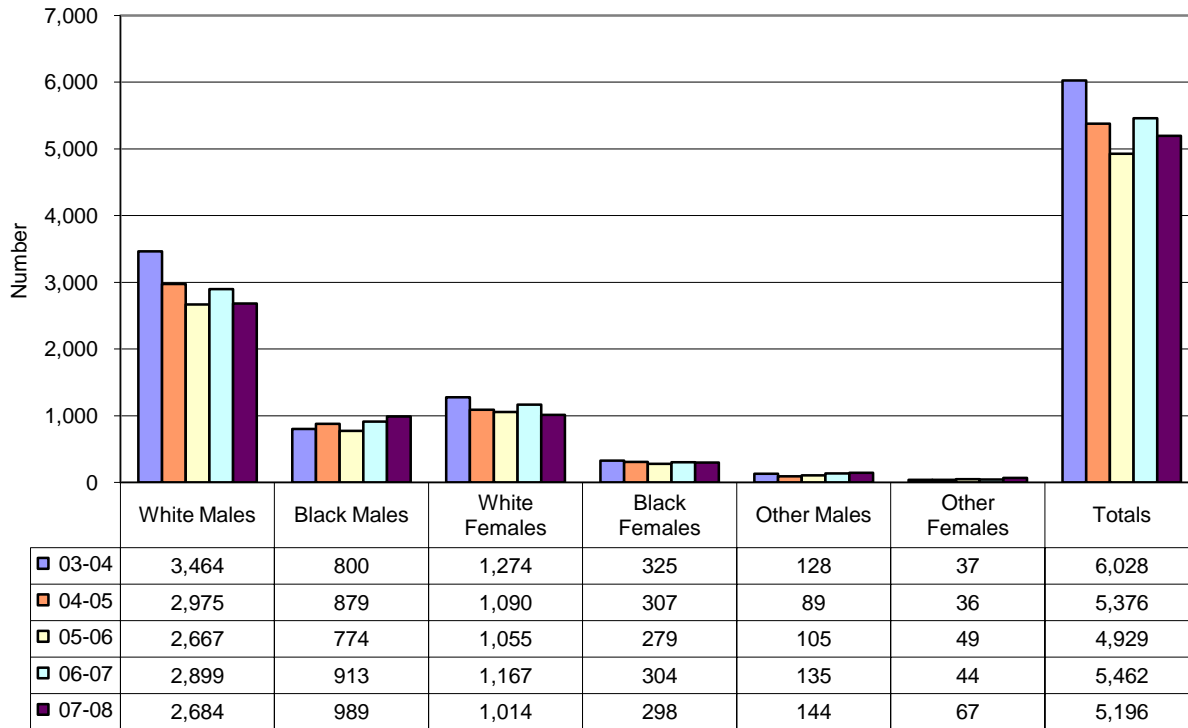

Disciplinary actions for all Law Violations, *Part I* and *II*, are depicted in **Chart 23**. Disciplinary actions for both *Part I* Law Violations (49.6%) and *Part II* Law Violations (10.5%) decreased substantially over the five years under study.

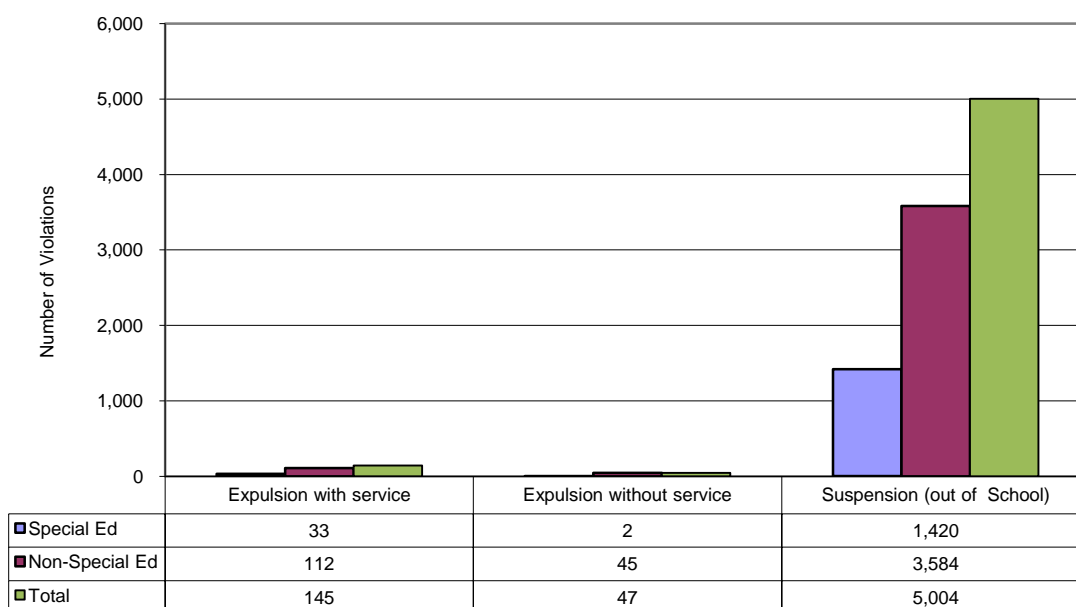

Race and gender comparisons are made in **Chart 24**. Disciplinary actions for Law Violations decreased slightly from 2006-2007 to 2007-2008 for White Males (7.4%), White Females (13.1%), and Black Females (2.0%) and for these groups over the five-year period (decreases of 22.5% for white males, 20.4% for white females, and 8.3% for black females during the five-year period). Nevertheless, disciplinary actions increased from 2006-2007 to 2007-2008 for Black Males (8.3%), Other Males (6.7%), and Other Females (52.3%) and over the five-year period as well (23.6% for Black Males, 12.5% for Other Males, and 81.1% for Other Females). Further exploration into the roots of these disparate findings is needed.

(2007-2008 School Year)**

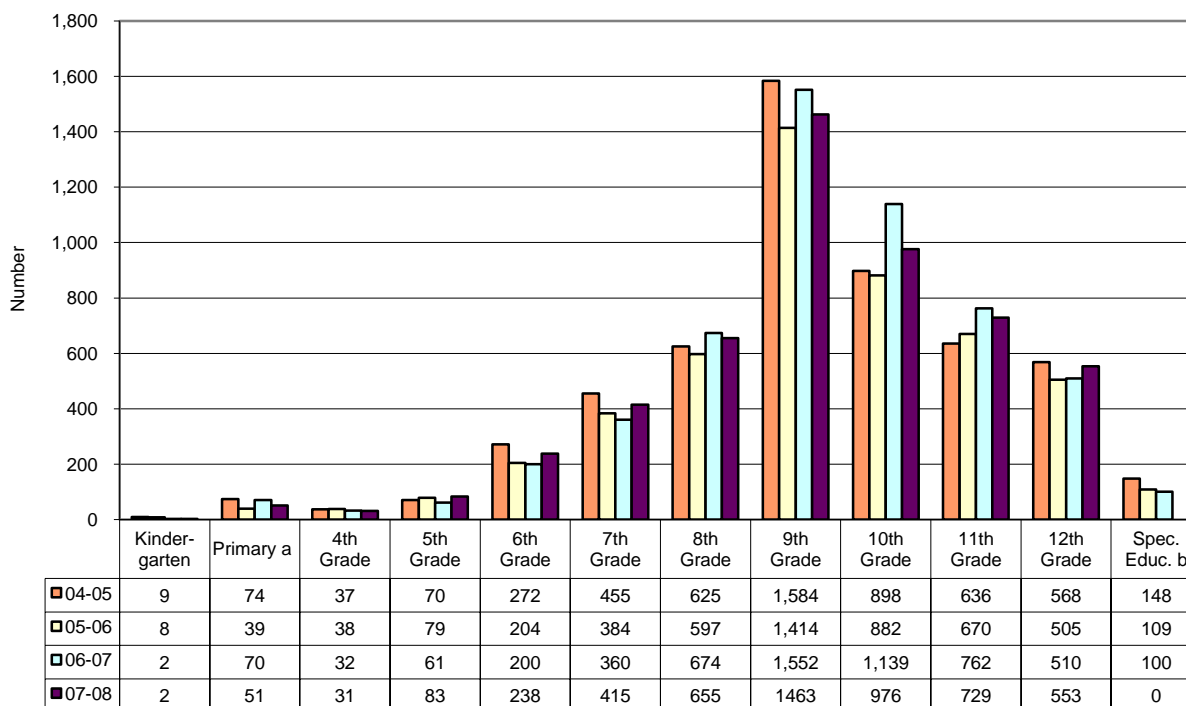

The comparison of disciplinary actions for law violations by IEP status is presented in **Chart 25**. The results presented in **Chart 25** suggest that approximately one in five students (18.6%) receiving expulsions with services for Law violations had an IEP in 2007-2008 while only two (4.1%) of those students receiving expulsions without service had an IEP. Approximately one in five (22.1%) students who were suspended for Law violations in 2007-2008 had an IEP. Given that approximately one in five (17.1%) students in public schools in Kentucky had an IEP in 2007-2008, these percentages suggest that the percentage of students receiving a disciplinary action for Law violations was generally comparable with the percentage of the total student population (17.1%) that had an IEP in 2007-2008.

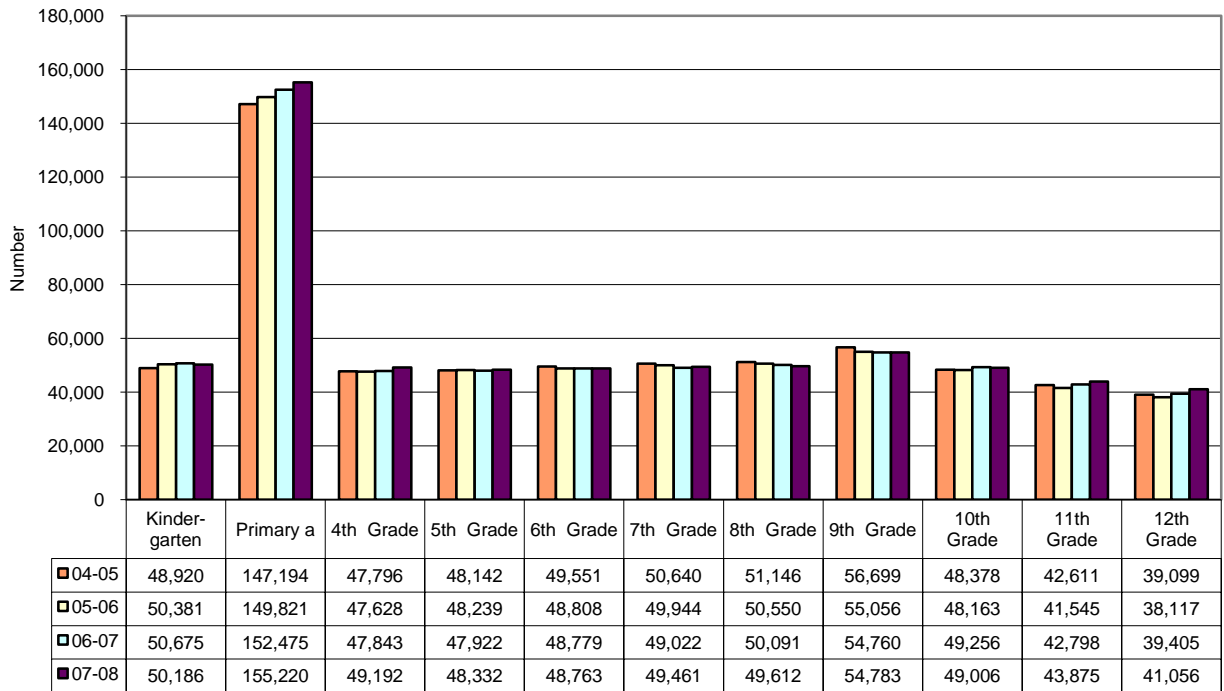

Grade level comparisons for Law Violations are displayed in **Chart 26a**. The profile of escalating Law Violations from Kindergarten through 9th grade with a decrease thereafter is similar to the profile presented in board policy violations. Because we were unable to collect grade-level data prior to 2004-2005, only four years of data are presented.

Total Enrollment by Grade ^a

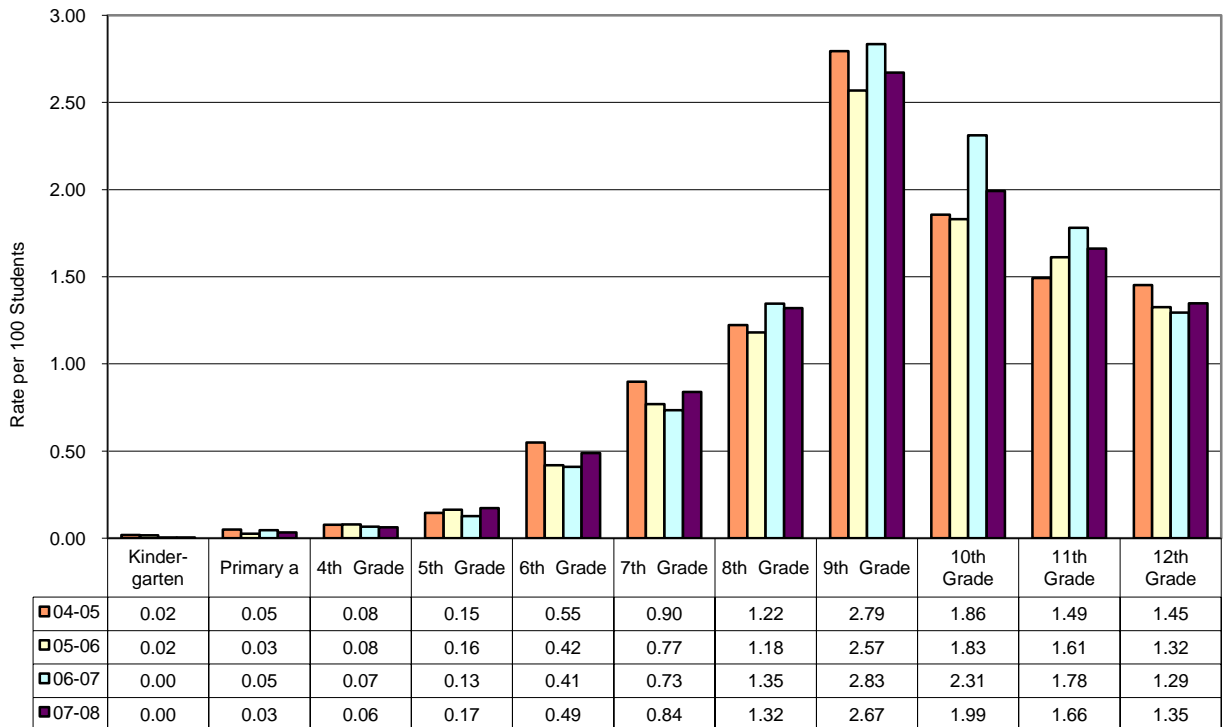

Chart 26b reflects the total enrollment for grades 4-12 while **Chart 26c** depicts the rate of Law Violations for each grade 4-12. As with disciplinary actions for Board Violations, the conversion to rates by student enrollment makes the increase in disciplinary actions from 8th grade to 9th grade appear less dramatic. Nevertheless, Chart 23c suggests a significant increase in the amount of disciplinary actions for Law Violations between middle school and high school, as the four highest rates of disciplinary actions for Law Violations occur in the high school grade levels, led by 9th grade (2.67 disciplinary actions per 100 students), 10th grade (1.99), 11th grade (1.66), and 12th grade (1.35). This finding suggests that disciplinary actions for Law Violations are a greater concern for high school students than for middle school students.

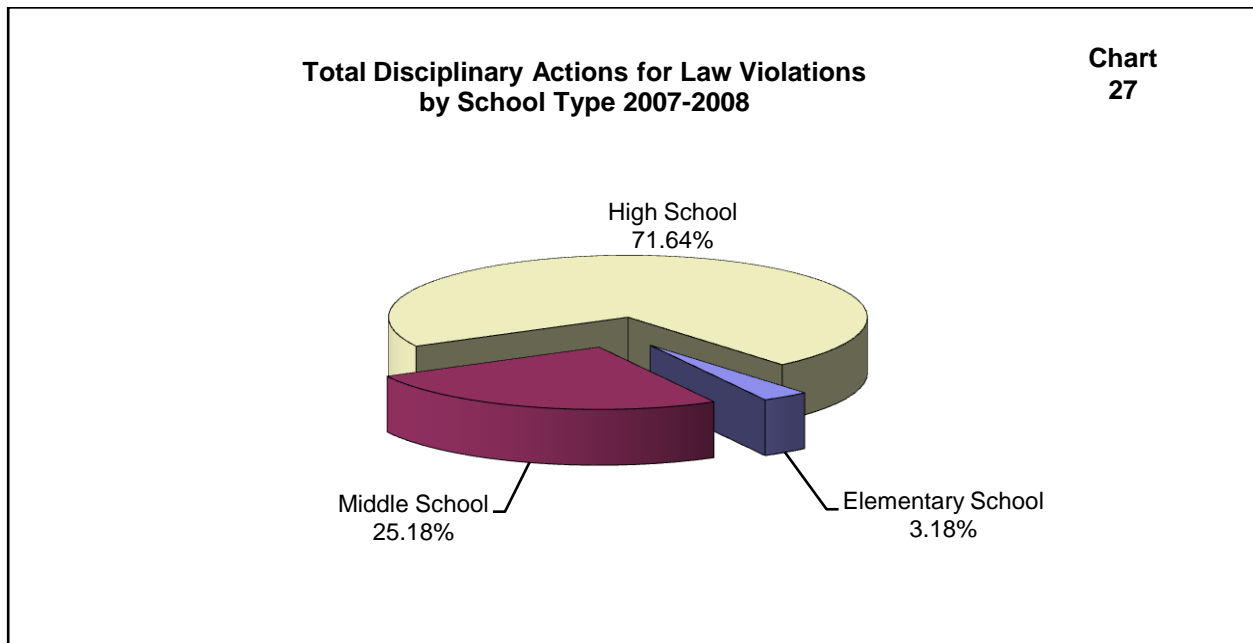


Chart 27 further suggests that disciplinary actions for Law Violations are more prevalent among high school students than middle school students as it illustrates that the vast majority (71.64%) of disciplinary actions for Law Violations occur at high schools while 25.18% and 3.18% of disciplinary actions for Law Violations take place at middle and elementary schools, respectively. Because the difference between the proportion of disciplinary actions for board policy violations between the middle and high school was more similar (36.10% for middle vs. 53.10% for high school), it is possible that a considerable number of middle school students who receive disciplinary actions for board policy violations develop into law-breaking offenders by high school. This suggests additional research into the pattern of behavior of offenders in the earlier grades and clearly demonstrates the need for unique identifiers in the data.

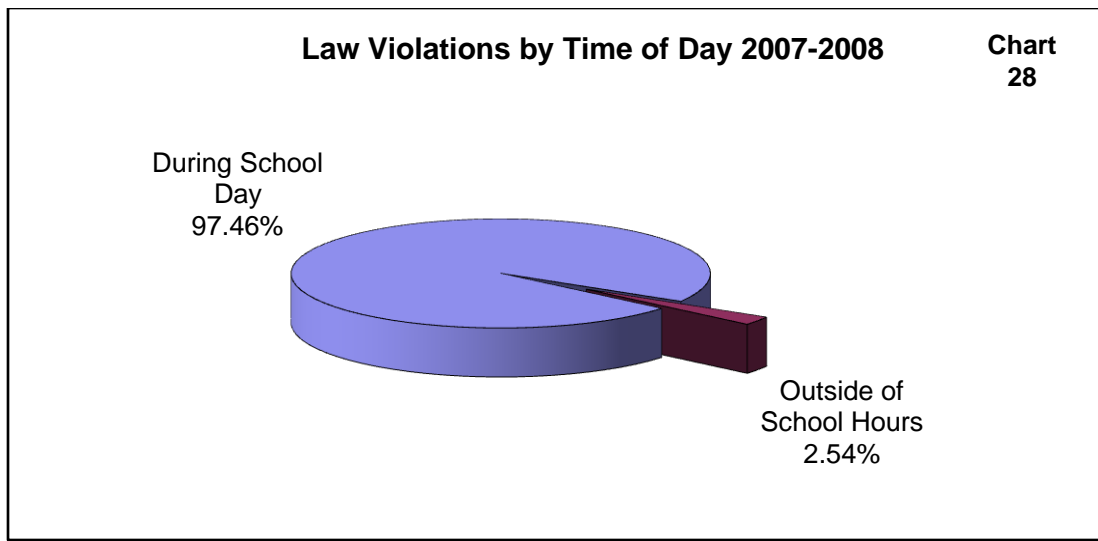


Chart 28 indicates the time of day that Law Violations were committed. Almost all of the incidents that incurred disciplinary actions for Law Violations (97.46%) occurred during schools hours while only 2.54% happened after school hours

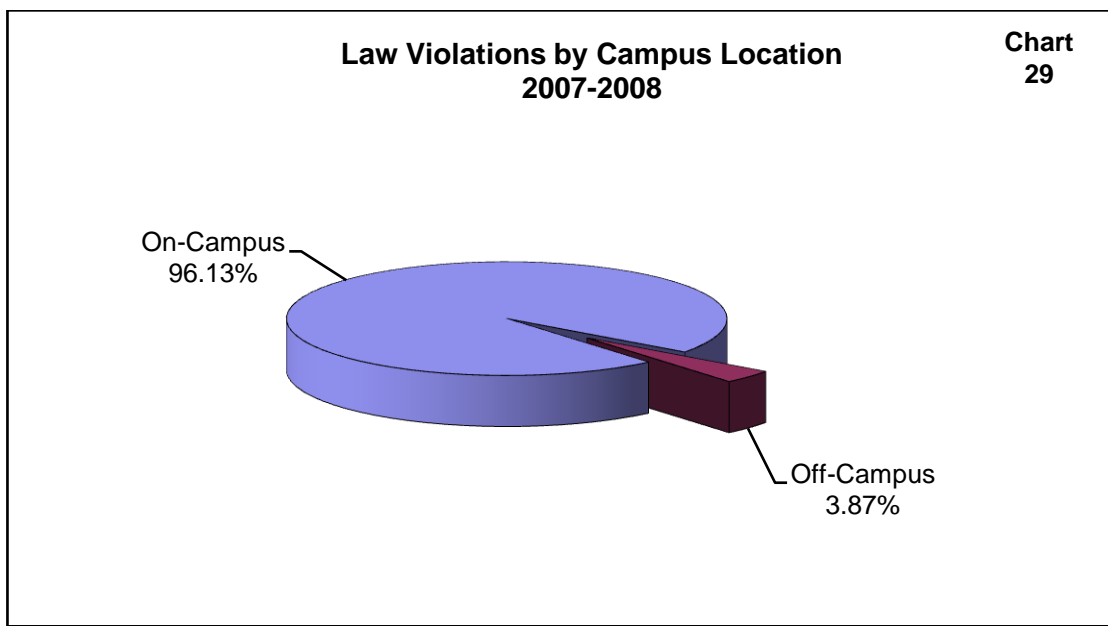
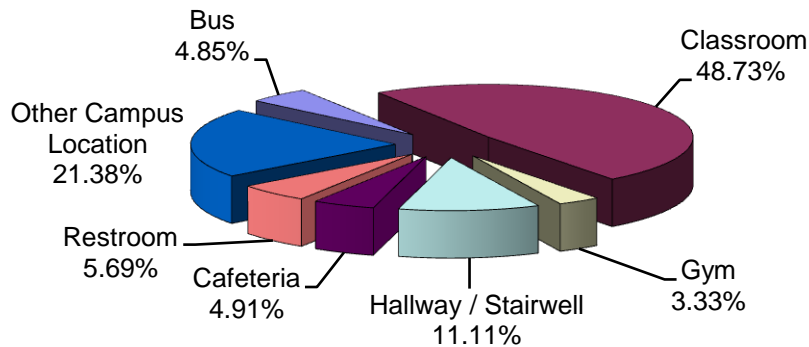


Chart 29 displays the location where the incidents that received disciplinary actions for Law Violations occurred (either on-campus or off-campus). On-campus violations comprise 96.13% of all disciplinary actions for Law Violations while off-campus Law Violations made up the remaining 3.87%. **Charts 28 and 29** clearly indicate that the preponderance of Law Violations occur during school hours and on school campus.

The locations at which Law Violations occur are further divided in **Chart 30**. Most (48.73%) Law Violations occur in the classroom. The remaining Law Violations were distributed across the following locations on-campus: other campus locations (21.38%), in the hallway/stairwell (11.11%), in the restroom (5.69%), in the cafeteria (4.91%), on the bus (4.85%), and in the gymnasium (3.33%).

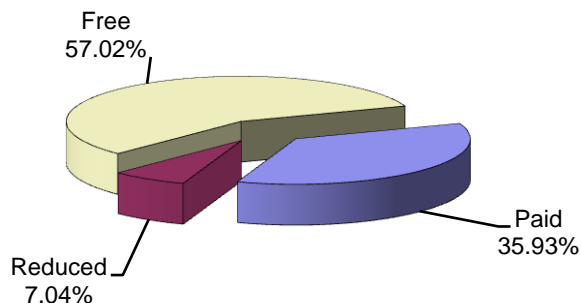


Chart 31 illustrates the total disciplinary actions for Law Violations by lunch type. Students who received free lunch made up 57.02% of the total disciplinary actions for Law Violations. Students who paid or received reduced lunch were responsible for 35.93% and 7.04% of the disciplinary actions for Law Violations, respectively. Comparing disciplinary actions for board policy and Law Violations by lunch type indicates that students who qualified for free lunch constituted a lower percentage of total disciplinary actions for Law Violations than for board policy violations (57.02% vs. 68.13%). Although the proportion of students (64.06%) receiving disciplinary actions for Law Violations who qualified for free or reduced lunches is greater than their representation in the general student population, this proportion is considerably lower than the proportion of students receiving disciplinary actions for Board Violations that qualify for free or reduced lunch (75.25%).

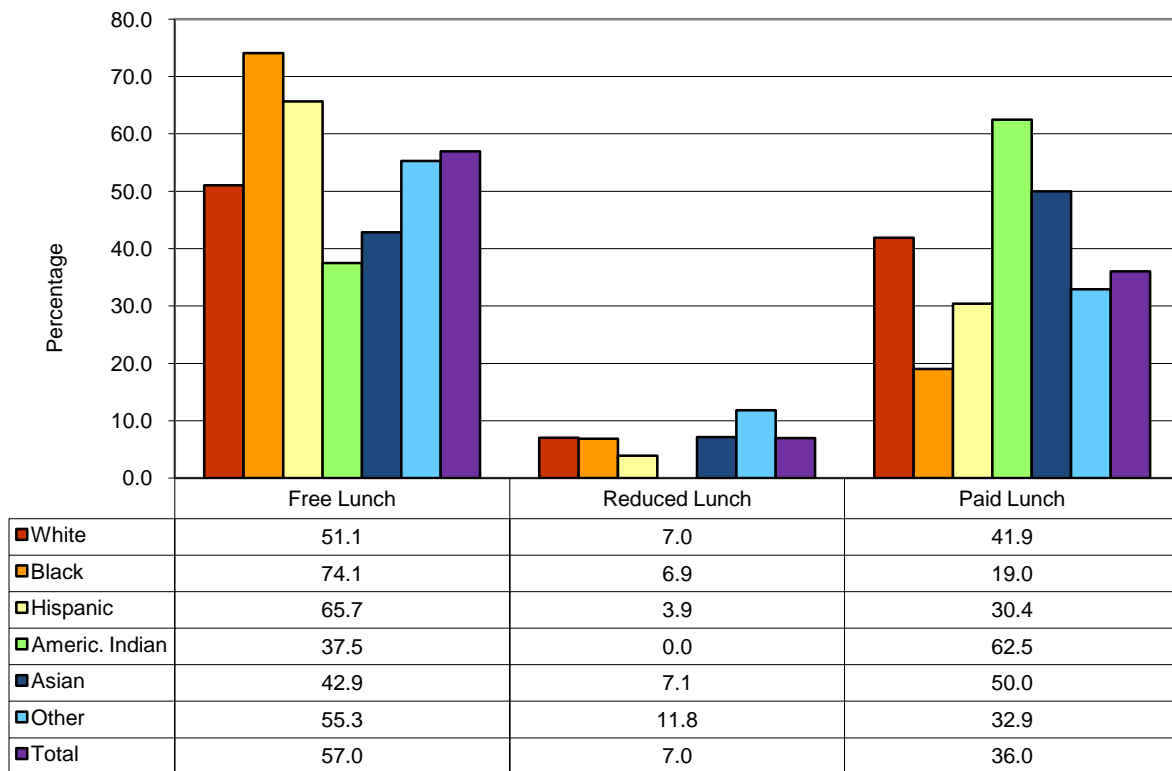


Chart 32 compares the percentages of those receiving disciplinary actions that received free lunch by race. As with board violations, the percentage of Blacks and Hispanics receiving disciplinary actions for law violations that received free lunch (74.1% and 65.7%, respectively) was much higher than the percentage of Whites receiving disciplinary actions for law violations that received free lunch (51.1%). Combined with an over-representation of Black, non-Hispanic students in disciplinary actions, these findings suggest that further study into the relationship between poverty, race and disciplinary actions is needed.

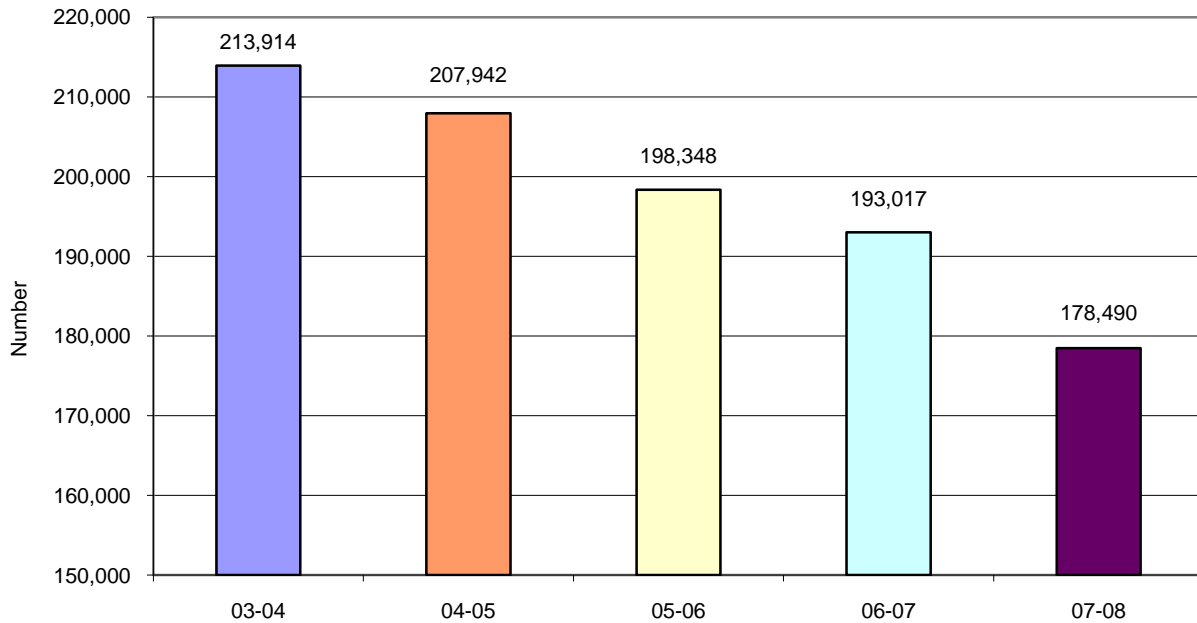


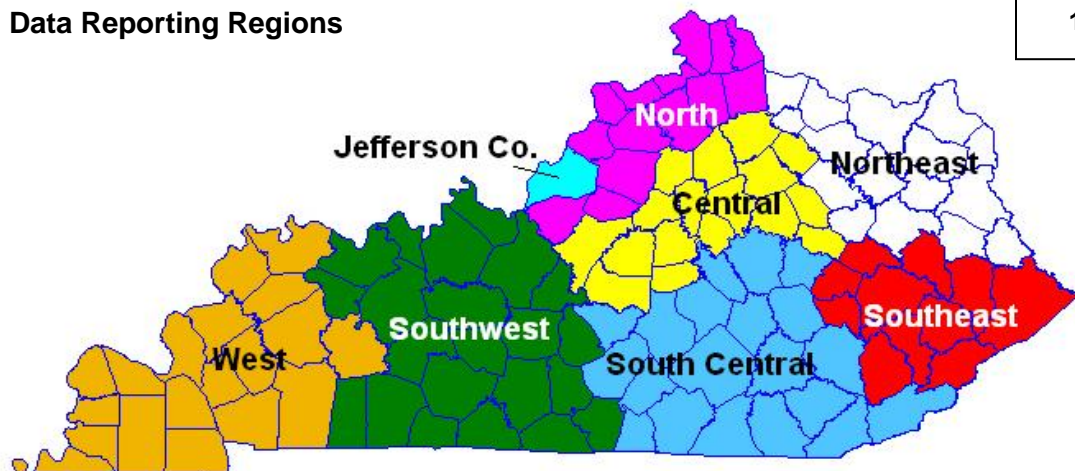
Chart 33 illustrates the number of school days that students were suspended from the 2003-2004 school year through 2007-2008 for Board and Law Violations. As with other data presented throughout the report, the total number of days missed by students for suspensions appears to have peaked in 2003-2004 and has declined steadily since (a 16.6% decrease over the five-year period). This is an encouraging finding, as it means that fewer instructional days have been missed each year during the five-year period because of disciplinary actions.

KCSS has divided the school districts into eight regions (**Map 1**) to maintain consistency with past reporting. This section of the report disaggregates the school safety data by these geographical regions to examine regional differences in disciplinary actions for board policy and Law Violations. Charts tracking these regional trends for five years are then included at the end of the section.

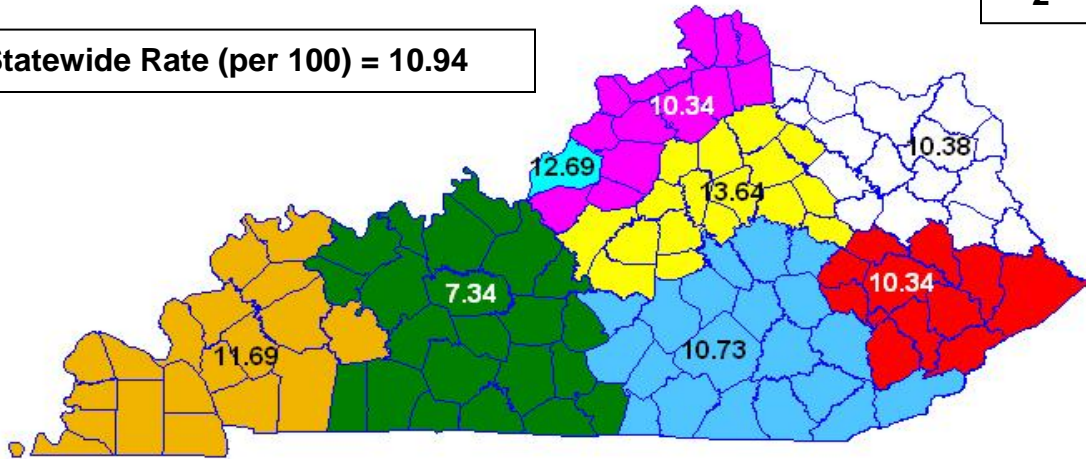

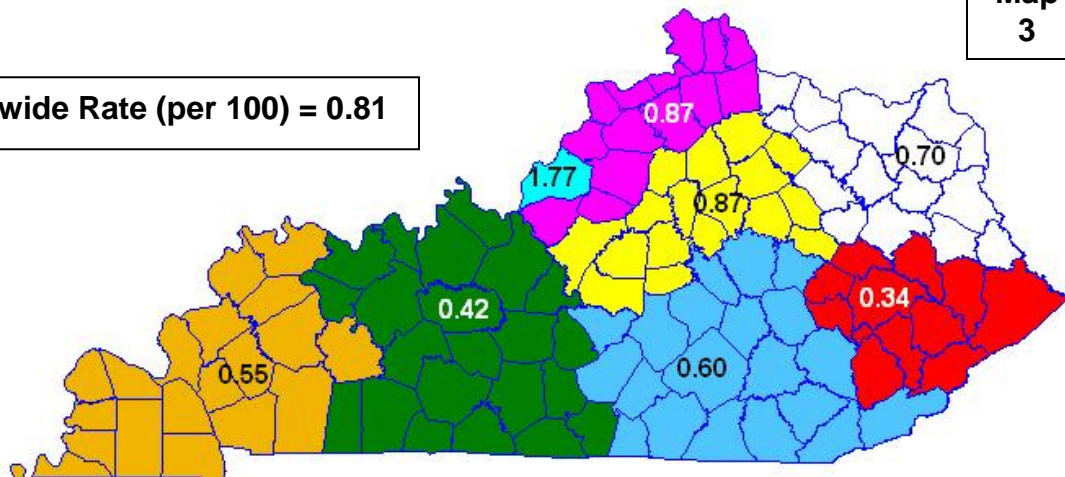


Map 2 shows the regional rate of **disciplinary actions for board policy violations** for all students. The Southwest region reports the lowest rate, 7.34 per 100 students, which is 32.9% below the statewide rate of 10.94 disciplinary actions per 100 students. The Central region and Jefferson county report the highest rates, 13.64 and 12.69, respectively. The rates in the other five regions range from 10.34 to 11.69.

Disciplinary Actions for Law Violations 2007-2008 – All Students

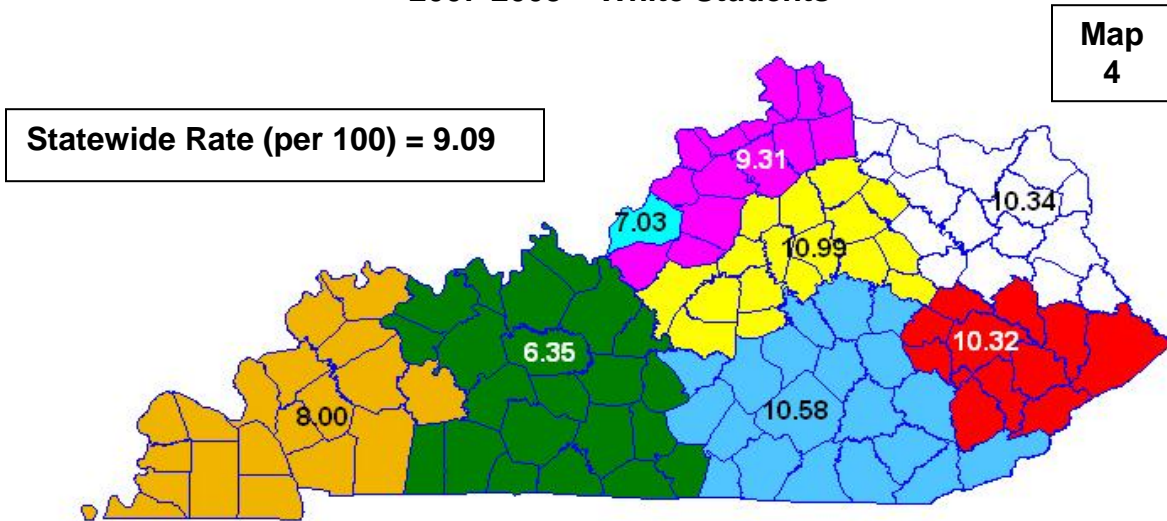

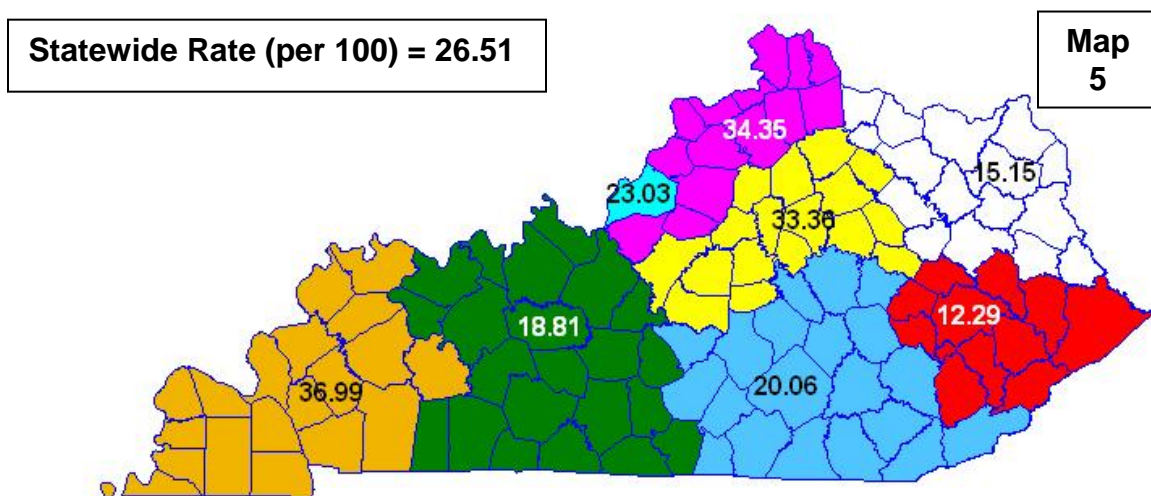
Map 3 depicts **disciplinary actions for Law Violations** for all students. The lowest rate for Law Violations occurred in the Southeast region, 0.34, while the highest rate occurred in Jefferson County, 1.77. Although Jefferson County has consistently reported the highest rate for Law Violations, the difference in all eight regions is little more than 1 disciplinary action for Law Violation per 100 students.

Disciplinary Actions for Board Policy Violations 2007-2008 – White Students

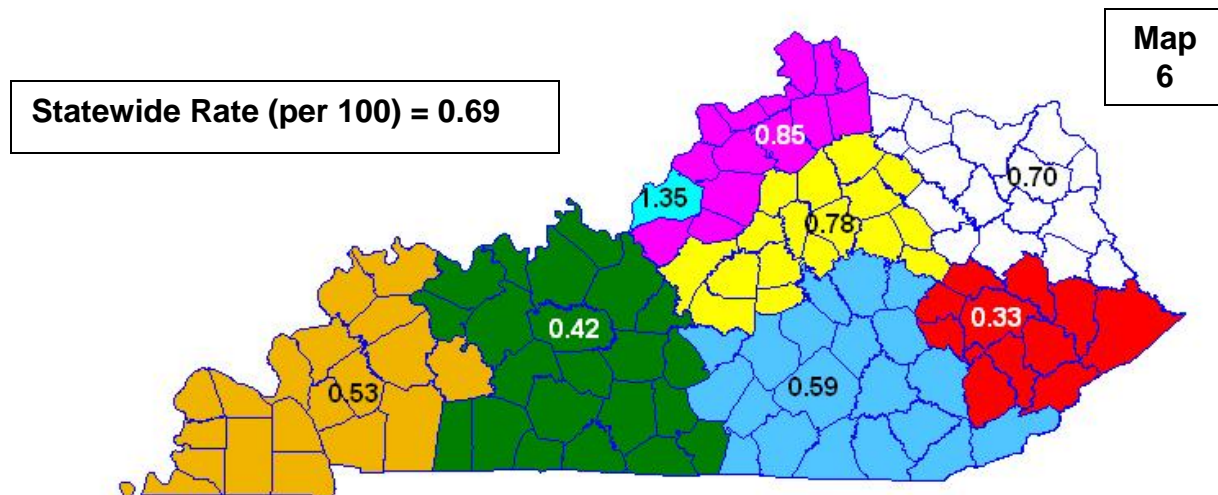


The results presented in **Map 4** and **Map 5** reflect the **disciplinary actions for board policy violations for white (Map 4) and black students (Map 5)**. A comparison of the statewide rates suggests that the statewide rate for disciplinary actions for board policy violations for black students is almost three times higher than the rate for white students (26.51 v. 9.09). The results further suggest that, for white students, the Southwest region has the lowest rate per 100 students (6.35) while the Central region reports the highest rate at 10.99. For black students, the West region reports the highest rate (36.99) while the Southeast region reports the lowest rate (12.29).

Disciplinary Actions for Board Policy Violations 2007-2008 – Black Students

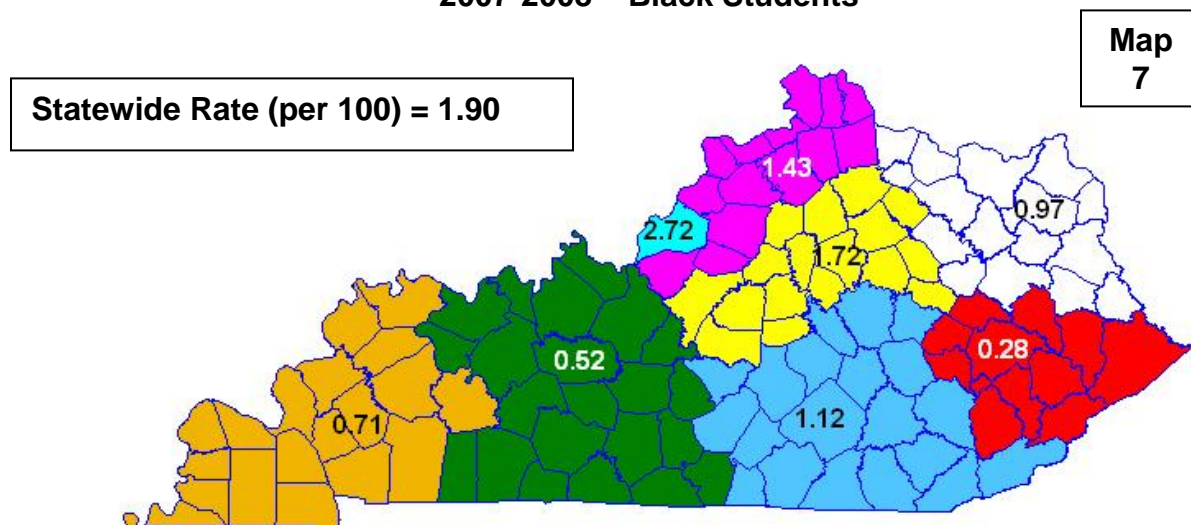


Disciplinary Actions for Law Violations 2007-2008 – White Students



The results presented in **Map 6** and **Map 7** reflect the **rate of disciplinary actions for Law Violations for white (Map 6) and black (Map 7) students**. As noted with disciplinary actions for board policy violations for black students, the statewide rate of disciplinary actions for Law Violations for black students (1.90 per 100 students) was more than double that rate for white students (0.69 per 100). Furthermore, Jefferson County had the highest rate of disciplinary actions for both white (1.35) and black (2.72) students. Additionally, the Southeast region has the lowest rate of disciplinary actions for both white (0.33) and black (0.28) students.

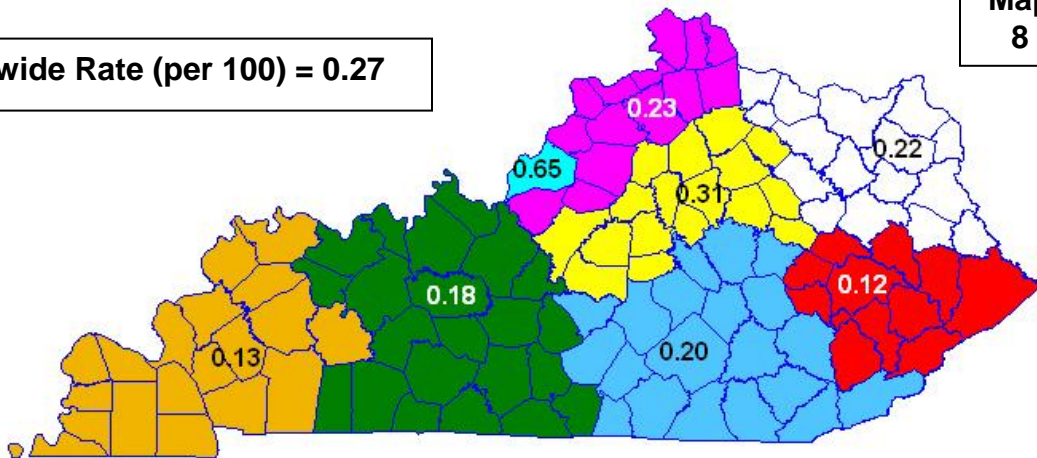
Disciplinary Actions for Law Violations 2007-2008 – Black Students

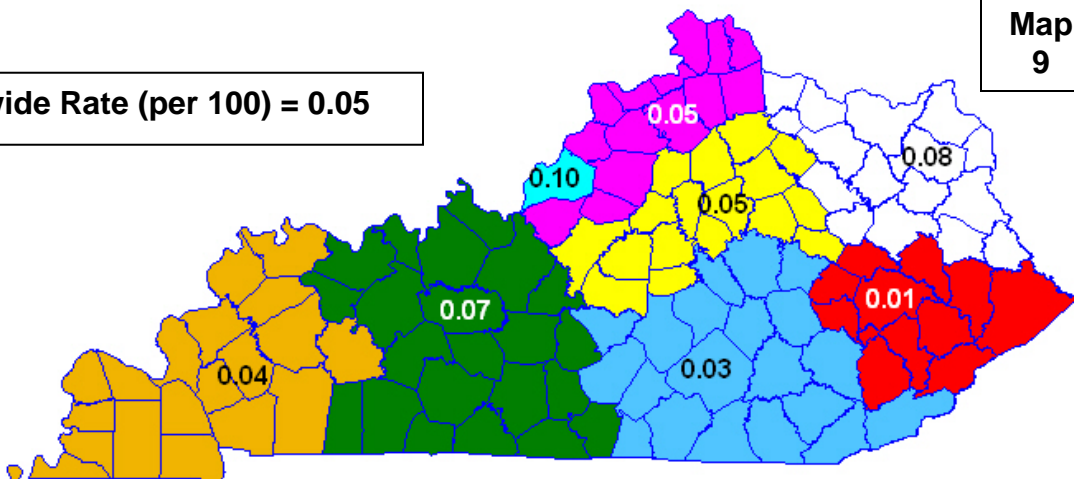

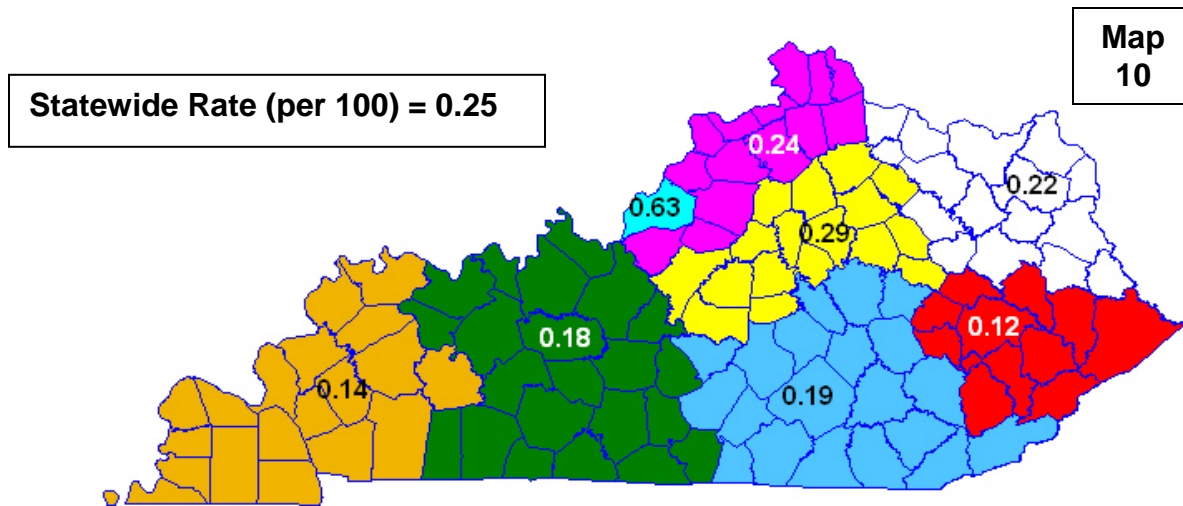

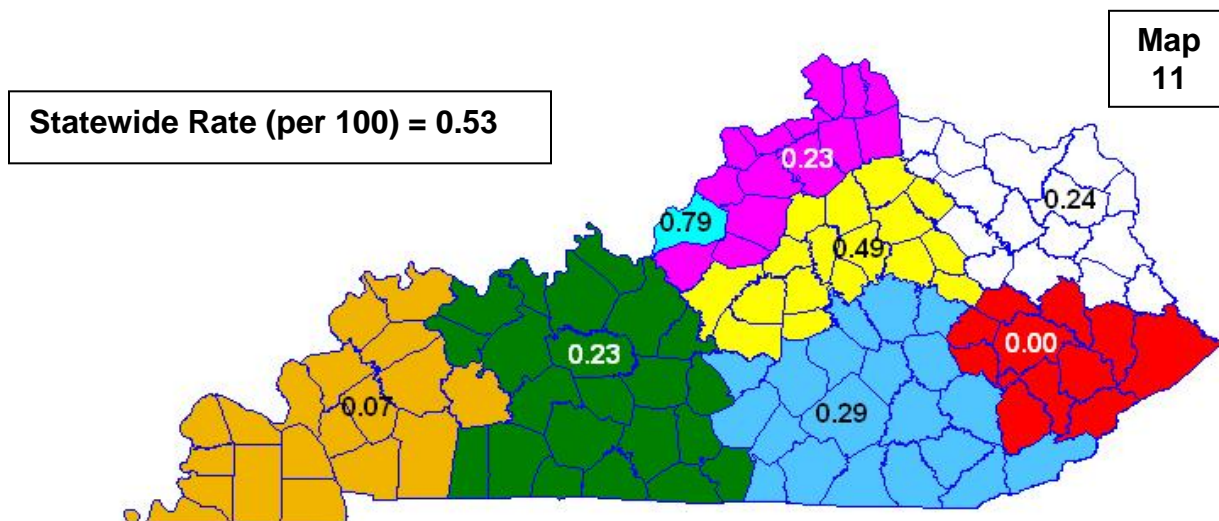

Disciplinary Actions for Drug Possession and Use Violations 2007-2008 – White Students



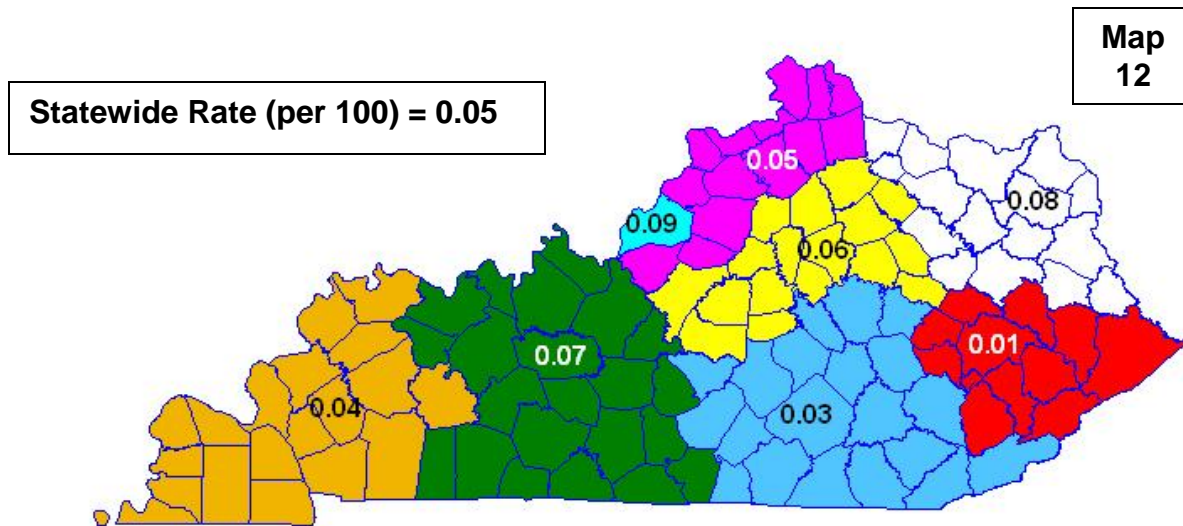

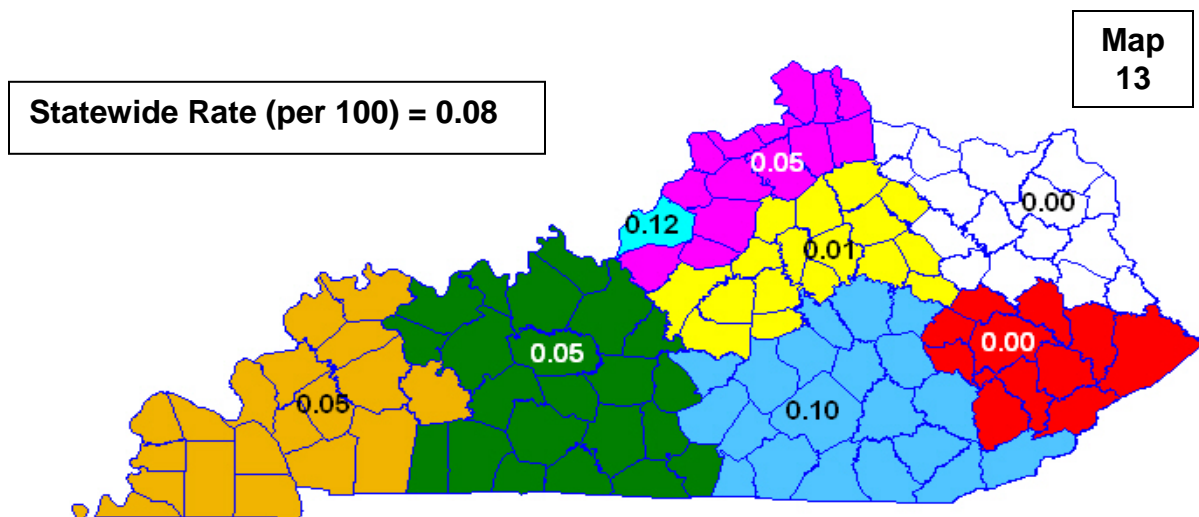

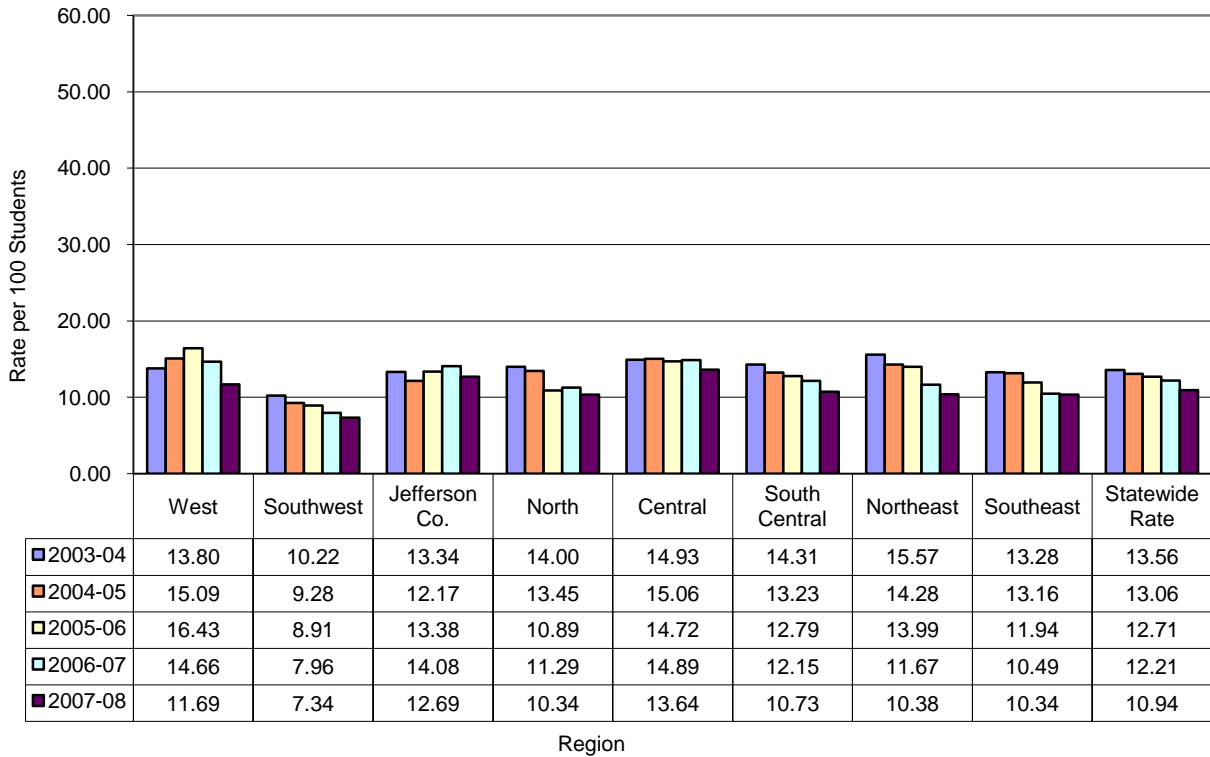

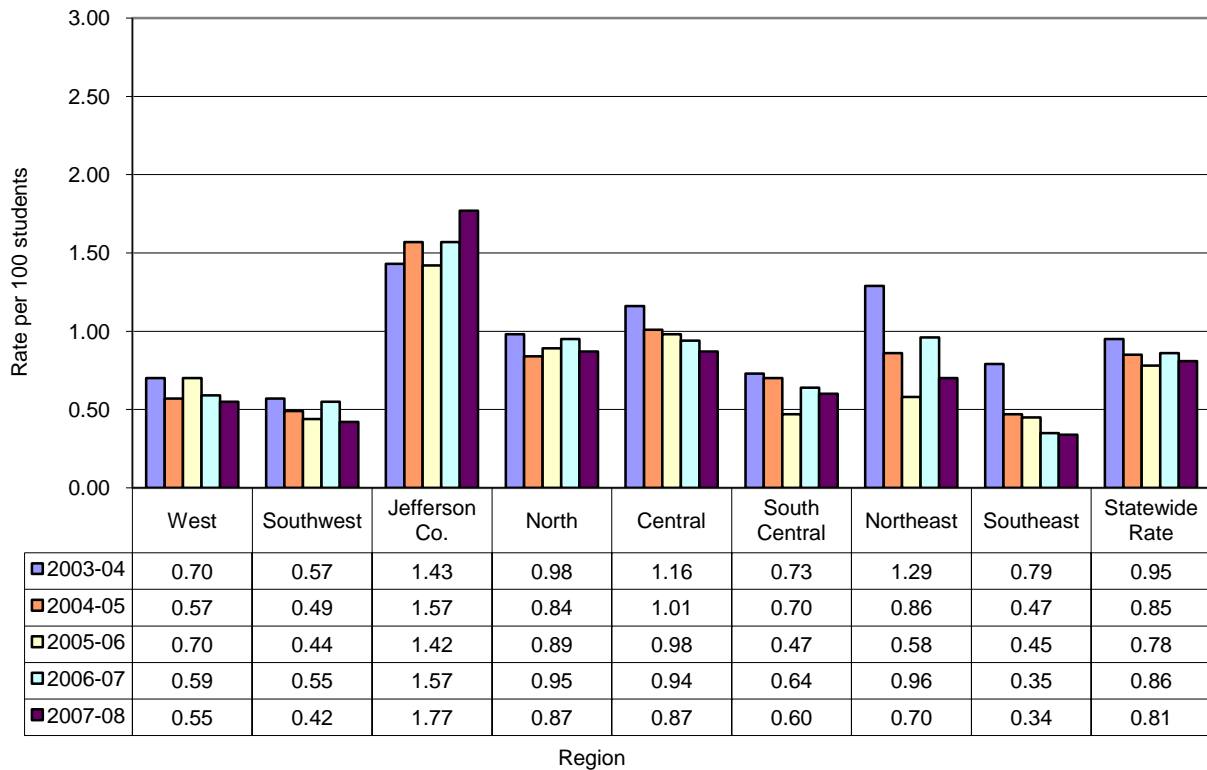

For the first time, in this report we present five-year trends in disciplinary actions by region. We begin with an analysis of five-year trends in disciplinary actions for board policy violations for all students (**Chart 34**). As the tables and charts throughout the report have indicated, since 2003-2004, the statewide rates of disciplinary actions for board policy violations have steadily decreased for the entire state (19.3%) and for all regions over the past five years. The greatest decrease occurred in the Northeast, dropping from 15.57 in 2003-2004 to 10.38 in 2007-2008, a decrease of 33.3%.

Five year trends for disciplinary actions for Law Violations for all students are presented in **Chart 35**. The statewide rate for disciplinary actions for Law Violations for all students decreased 14.7% between the 2003-2004 and 2007-2008 school years. With the exception of Jefferson County (where disciplinary actions for Law Violation rates increased 23.8% over the five-year period), all of the regions experienced decreased rates from 2003-2004 until 2007-2008. The greatest decrease occurred in the Southeast, where the disciplinary action for Law Violations rate dropped 57.0% over the five-year period.

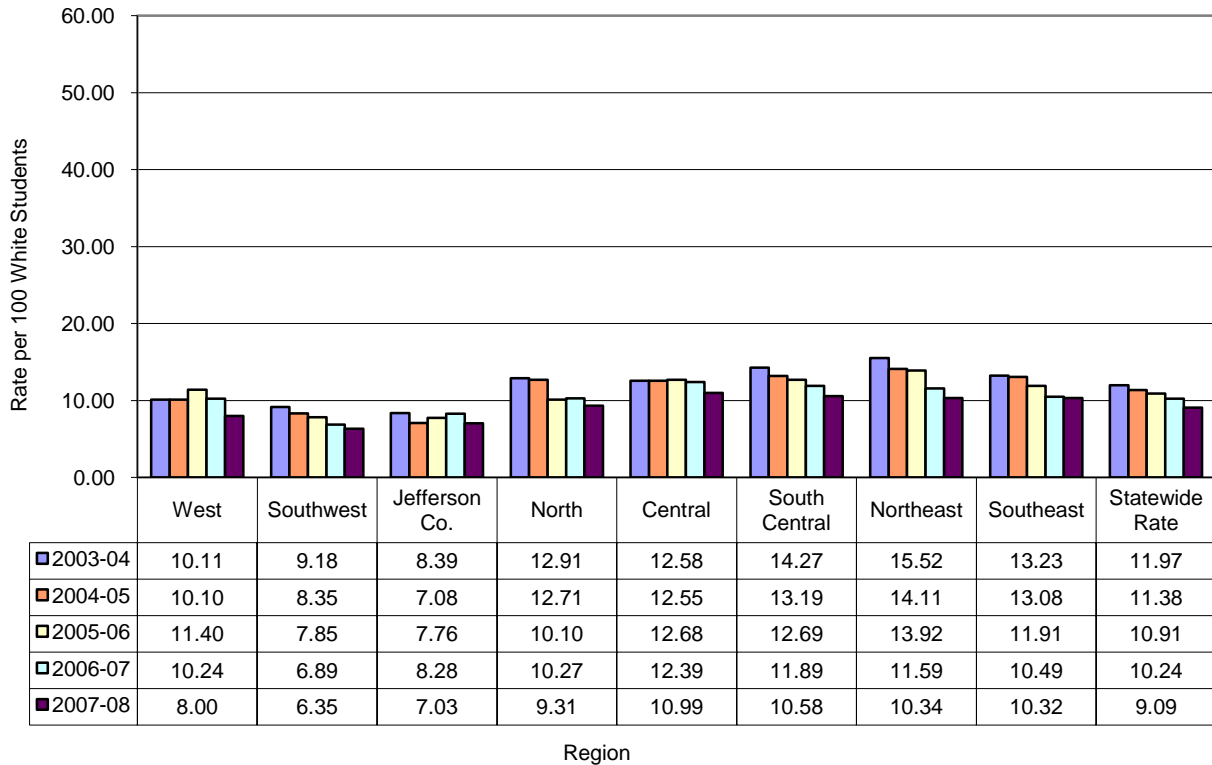


Chart 36 depicts five-year trends in disciplinary actions for Board Violations for white students for each of the eight regions and the state. As with the board policy violation rates for all students, the statewide rates for board policy violations have steadily decreased for white students as well (24.1% over the five-year period). Disciplinary actions for Board Violations for white students also decreased in each region during the five-year period. The greatest decrease occurred in the Northeast, where the rate dropped from 15.52 in 2003-2004 to 10.34 in 2007-2008, a decrease of 33.4%.

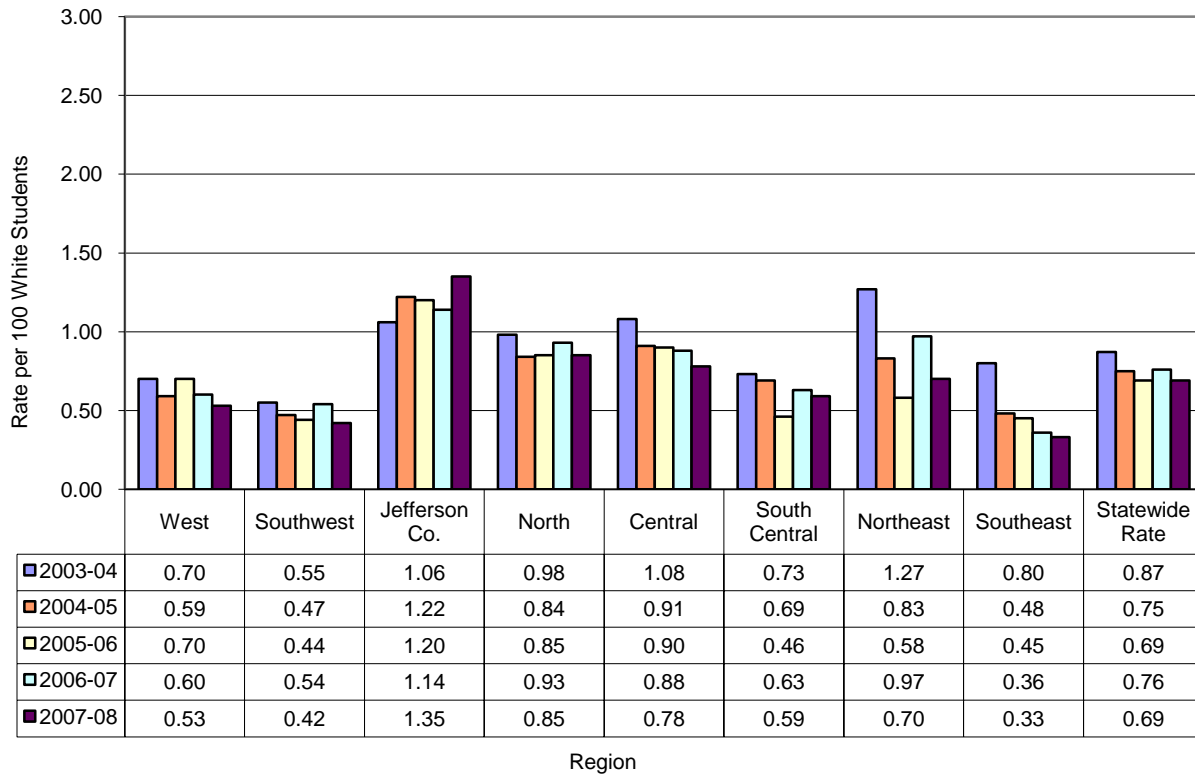


Chart 37 depicts five-year trends in disciplinary actions for Law Violations for white students for each of the eight regions and the state. As with the board policy violation rates for white students, the statewide rate for disciplinary actions for Law Violations for white students has decreased over the five-year period (20.7%). With the exception of Jefferson County (where disciplinary actions for Law Violation rates increased 27.4% over the five-year period), all of the regions experienced decreased rates from the beginning of the time period until 2007-2008. The greatest decrease over the five-year period occurred in the Southeast (a decrease of 58.8%).

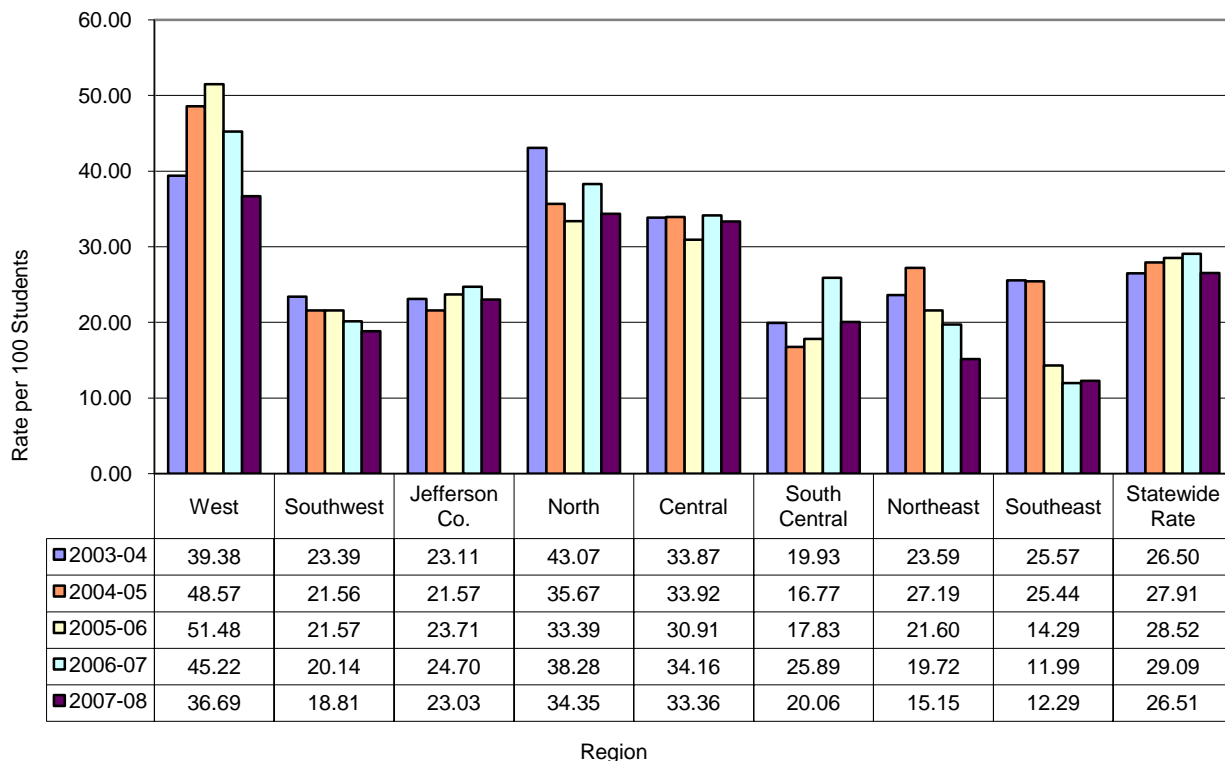


Chart 38 depicts five-year trends in disciplinary actions for Board Violations for black students for each of the eight regions and the state. Unlike the board policy violation rates for all students and white students, the statewide rates for board policy violations among black students have, while fluctuating some during that time, remained relatively stable over the five-year period. Although the rate of disciplinary actions for Board Violations for black students decreased in most regions, the rate increased slightly in the South Central region. The greatest decrease occurred in the Southeast, where disciplinary actions for Board Violations decreased 51.9% over the five-year period.

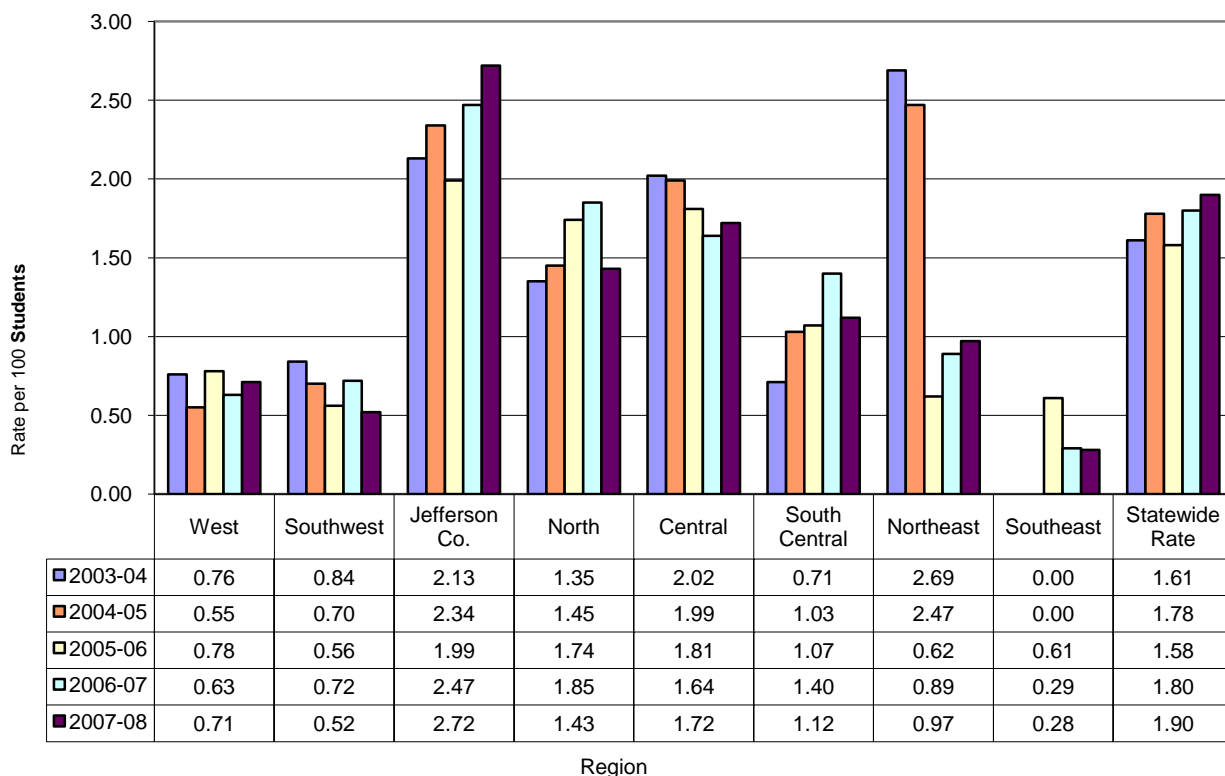
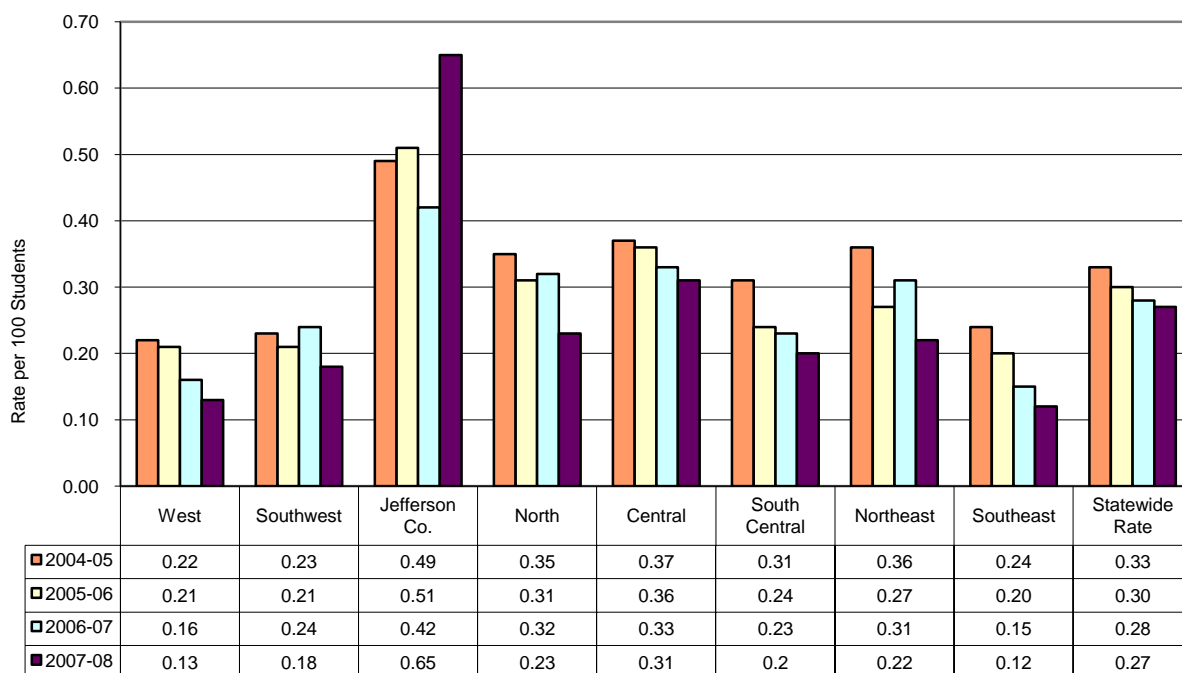


Chart 39 depicts five-year trends in disciplinary actions for Law Violations for black students for each of the eight regions and the state. Unlike the disciplinary actions for Law Violation rates for white students, the statewide rates for disciplinary actions for Law Violations have increased for black students (18.0% over the five-year period). Additionally, the statewide rate also increased slightly (5.6%) from 2006-2007 and 2007-2008. The disciplinary actions for Law Violations rates for black students increased in four districts during the five-year period; nevertheless, the rates decreased dramatically in the Northeast (a decrease of 64.0%).

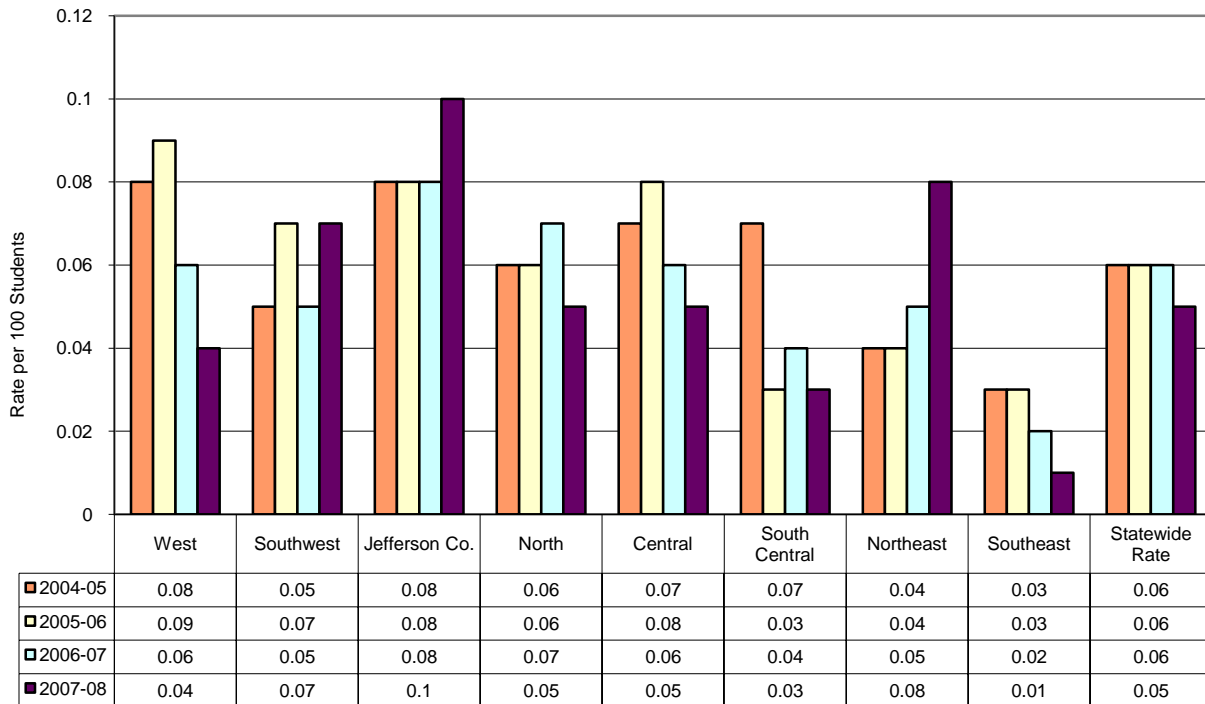

Because we have only been able to collect data that distinguish drug possession and use from drug distribution for four years, **Charts 40** and **41** contain only four years of data regarding trends in disciplinary actions for drug possession and use and drug distribution. The data presented in **Chart 40** suggest that the statewide rate of disciplinary actions for drug possession and use for all students has decreased slightly (18.2%) over the four-year period. With the exception of Jefferson county, where the rate increased 32.7%, the rate of disciplinary actions for drug possession and use decreased over the four-year period in each region.

The data presented in **Chart 41** reflect four-year trends in disciplinary actions for drug distribution. These data suggest that the statewide rate of disciplinary actions for drug distribution for all students has remained stable for the four-year period (between .05 and .06 per 100 students). Three regions (Jefferson county, the Southwest region, and the Northeast region) had slight increases over the four-year period; the rates in the remaining counties remained stable or decreased over the four-year period under study.

Districts are encouraged to examine their data over the three years of reporting. Additionally, districts are encouraged to make comparisons to other districts of similar size, to their region, and to the state. Similar comparisons can be made between building level data to other schools in their district as well as comparisons to their district, region, and the state. Keep in mind that data should be reviewed in context to understand the full meaning of the data and to avoid misinterpretation.

Section IV District Level Data

Occurrence of School District Disciplinary Consequences for Law and Board Violations

Table I reports the number of disciplinary actions for law and Board Violations for each Kentucky school district from the 2005-2006 school year until the 2007-2008 school year. County districts (in bold type) are organized alphabetically with independent school districts shown beneath the county school district they adjoin. The data in this table represent the raw number of reported disciplinary consequences associated with specific incidents. Attendance data collected by the Kentucky Department of Education (KDE) are shown in the enrollment column. Membership data are collected once yearly and are the most accurate snapshot of a district's total number of students.

Note: Local school boards are responsible for determining what disciplinary consequences are permissible in their schools. Some school boards have enacted policies prohibiting the use of corporal punishment; therefore, the data contained in the following table under corporal punishment reflect only those districts where it is allowed.

Standard Scale of Measurement

The following tables utilize a standard scale of measurement, rate per 100, to facilitate comparison between districts of dissimilar sizes. Therefore, the rate listed indicates how many incidents occurred in relation to every 100 students in the given districts. Districts are grouped by size to allow for more meaningful comparisons and, due to the small number of expulsions across the state, expulsions with and without services are combined in these tables. District rates for disciplinary actions for all students are shown in **Table 2**. The same data are shown in **Tables 3** and **4**, but have been disaggregated to show the rates for white and African-American students.

Note: A relatively small number of incidents can have a more dramatic effect on the rate per 100 in very small districts and in districts with a small number of African-Americans which may distort interpretation.

Districts **not found** in **Tables 3** and **4** were not reported at the district level because the number of African-American students was so small that reporting the numbers might make them “personally identifiable” in violation of federal privacy laws (Federal Educational Rights and Privacy Act, FERPA). Because their numbers were so small in most counties, the concern for violating the privacy laws also results in the omission entirely of Asian, Hispanic, American Indian, and other racial groups from the tables. We did not include those districts in either table to preclude readers from being able to mathematically calculate how many African-Americans or students of other races received these violations.
