2. Topics for School Based Law Enforcement Agencies – When a School District is Your Employer (Cafeteria)

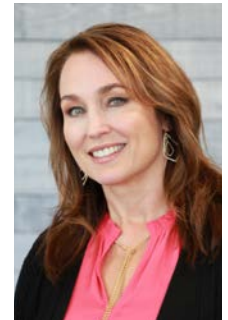
